Course Description

This course provides an overview of analytical tools that economists use to solve business problems, as well as exposure to the economic environment within which businesses operate. Key concepts and ideas from both microeconomics and macroeconomics are introduced. The focus is to enable students to be able to identify, understand, and evaluate both domestic and global drivers causing economic change. Particular attention is given to discussions of real-world applications.

Exams

The first exam will focus on microeconomics material, while the second exam will be comprehensive, covering all the content covered throughout the course. Both exams will include a combination of multiple-choice and short-answer questions and must be submitted by the end of exam week. Make-up exams will not be offered. By enrolling in this course, you agree to take all exams on the scheduled dates. In exceptional circumstances, if a student is unable to take an exam due to a documented and approved reason, the weight of the missed exam will be reallocated to the remaining graded components. Approval will only be granted with official written documentation from an authoritative source explaining the reason for the absence. Both exams will be open notes and open book, but only printed (hard copy) materials may be used—digital files or devices are not permitted during the exams.

Group Project

Each group will select one topic from the list provided on the course page. The project will involve analyzing, modeling, and forecasting a specific firm, industry, or organization using relevant economic, demographic, and financial indicators. A PowerPoint presentation is required and must be submitted through the course page. Each group member is expected to participate by contributing to the project and submitting a recorded portion of the presentation. Active participation from all group members is required. A written report is not required.

Participation

Active participation is essential to the success of this course. You are expected to contribute regularly to class discussions and come prepared to engage each week. In addition, you should be ready to answer questions and work collaboratively on group assignments. Group member details are available on the course page. Beyond graded assignments, you will have access to optional problem sets aligned with each week's topics. While not required, these exercises are highly recommended as they will help reinforce key concepts and prepare you for the exams. Solutions to the problem sets will be provided in each weekly module on the course page.

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Taking an exam
- Participating in online labs

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 2. Asynchronous Courses: All class meetings are asynchronous.
2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
