COURSE DESCRIPTION

This course focuses on a data-driven approach to operations and supply chain management for business process improvement. Students will be introduced to key concepts of business process management using the principles of operational excellence and will learn how to identify, document, model, assess, and improve core business processes along the value chain. Emphasis will be placed on the way in which information technology can be used to manage, transform, and improve business processes.

COURSE MODALITY DEFINITIONS

1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a. Synchronous Courses: At least one class meeting takes place at a designated time.
 - b. Asynchronous Courses: All class meetings are asynchronous.
 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
