Course Description

This course introduces students to disciplinary expectations for research in communication, including source evaluation and citation, and equips them to review literature, evaluate theories, select methods, and propose ethical research in communication from qualitative and quantitative perspectives.

 2. Extract the most salient points from disciplinary research articles
 3. Select appropriate and ethical research methods for a variety of hypotheses or research questions
 4. “Speak the language” of communication research methods
 5. Cite scholarly research using discipline-appropriate style
 6. Evaluate social scientific paradigms and theories and understand their role in research

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Taking an exam
- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
