Course Description

An introduction to Strategic Communications is a multidisciplinary unifying framework of advertising, public relations, marketing communications, and data science. The course will examine foundational theories and practices of government, corporations, civic organizations, and social movements that allocate communication resources to purposefully capture the attention of the public sphere, create an array of stakeholder relationships, and advance the organization's mission-driven strategies.

"Whether it is energy or entertainment, politics or technology, sports or medicine, no company can survive without effective strategic communication (p.30)."

Hallahan, Holtzhausen, Ruler, Vercic, and Sriramesh (2007) – the authors of *Defining Strategic Communication* – point out, "The emphasis is on the strategic application of communication and how an organization functions as a social actor to advance its mission."

This course will examine case studies and best practices in the field. Emphasis is placed on advancing the theory and practice of strategic communications from an ethical Christian perspective.

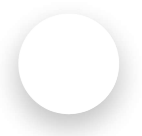

PLNU Attendance and Participation Policy



Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an “F” grade.

Online Asynchronous Attendance/Participation Definition

Course Modality Definitions
