Point Loma Nazarene University exists to provide higher education in a vital Christian community where minds are engaged and challenged, character is modeled and formed, and service is an expression of faith. Being of Wesleyan heritage, we strive to be a learning community where grace is foundational, truth is pursued, and holiness is a way of life.

Course Description

This course examines cinema as both an artistic medium and a cultural force through the study of diverse voices in film. Students analyze how cinematic meaning is constructed through film form, including framing, editing,

sound, narrative, and genre, while critically engaging representations of race, ethnicity, gender, class, Indigenous identity, environmental justice, and global cultural perspectives.

The course traces how early cinema contributed to systems of exclusion and stereotype and highlights how marginalized filmmakers reclaim and redefine representation through authorship, aesthetics, and storytelling. As part of a Christian liberal arts context, students are invited to reflect on ethical responsibility, human dignity, and the power of storytelling in shaping how we see and engage others.

Course Learning Outcomes

By the end of this course, students will be able to:

1. Analyze cinema as a formal language by identifying how cinematic techniques such as framing, editing, sound, narrative structure, and genre shape meaning and audience interpretation.
2. Critically evaluate representations of identity and power in film, including race, ethnicity, gender, class, Indigenous identity, environmental justice, and global cultural perspectives.
3. Situate films within historical, cultural, and political contexts, recognizing how cinema has contributed to both the reinforcement and challenge of dominant social narratives.
4. Apply film studies terminology and critical frameworks in written analysis, discussion, and research-based work with clarity and precision.
5. Reflect on the ethical dimensions of representation and storytelling, considering questions of human dignity, responsibility, and empathy within a Christian liberal arts context.
6. Produce a sustained, research-based film analysis using MLA style and scholarly sources.

Content Warning

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive various types of information. If you encounter a topic that is intellectually challenging for you, it can manifest in feelings of discomfort and upset. In response, I encourage you to come talk to me or your friends or family about it. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of diverse voices in cinema, and I will support you throughout your learning in this course.

Trigger Warning

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In ENG3051 Diverse Voices in Cinema, we will cover a variety of topics, some of which you may find triggering. These topics include racism, racial violence, colonialism, sexism, misogyny, class inequality, Indigenous erasure, environmental exploitation, war, authoritarianism, trauma, and death. Some early films contain explicitly racist imagery and stereotypes, which are included for critical analysis and historical understanding, not endorsement. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on a discussion of a certain topic, know that you are still responsible for the material, but we can discuss if there are other methods for accessing that material and assessing your learning on that material.
