Course Description

This course introduces graduate students to the principles, theories, and methods of bioethical analysis. Students will explore major ethical frameworks and their application to contemporary issues in medicine and biomedical

research, including patient autonomy, informed consent, end-of-life decision making, allocation of scarce resources, emerging biotechnologies, and professional responsibility. Through case studies, readings, and discussion, students will develop skills in ethical reasoning and critical reflection that are essential for responsible practice and leadership in health care and biomedical sciences. (Letter grade)

Course Learning Outcomes

The following learning outcomes will be achieved by students in this course:

1. Articulate the important philosophical, legal, and professional concepts and arguments in medical ethics.
 2. Accurately identify ethical issues and evaluate their relative importance in case studies in medical ethics.
 3. Reflect on the virtues of good medical practitioners/researchers and how being a medical practitioner/researcher fits into your other life-shaping commitments
 4. Defend a position on a question of philosophical or moral significance in medical ethics.
 5. Engage and collaborate productively and respectfully with your peers/colleagues

Content Warning

Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of medical ethics, and I will support you throughout your learning in this course.

Trigger Warning

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In Foundations of Medical Ethics, we will cover a variety of topics, some of which you may find triggering. These topics include abortion and suicide. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of medical ethics and I will support you throughout your learning in this course.

PLNU Attendance and Participation Policy

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an “F” grade.

Synchronous Attendance/Participation Definition

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs

- Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 2. Asynchronous Courses: All class meetings are asynchronous.
 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

Participation:
