Course Description

Explore the fundamental principles of applied psychology and their relevance to everyday life. This course introduces students to the core concepts, theories, and methods of applied psychology, emphasizing the practical application of psychological knowledge in personal and professional contexts. Topics include self-awareness, emotional intelligence, and strategies for enhancing well-being.

Course Learning Outcomes

1. **Recognize key concepts** in applied psychology and explain how they relate to everyday life (PLO 1). This outcome will introduce you to various career options by helping you connect psychology's foundational principles with potential fields like healthcare, education, and user experience.
 2. **Describe foundational psychological theories** and how they apply to practical issues, preparing you for deeper study in subsequent courses (PLO 2). This outcome will help you understand how psychological theories are applied in real-world settings, equipping you to make informed career choices in fields where psychology is practically applied.
 3. **Explore the intersection of psychology, society, and Christian faith**, examining how psychological principles can align with faith-based values (PLO 3). This outcome encourages you to consider psychology's role in promoting ethical practices and social impact, providing a foundation for careers in social advocacy and community work.
 4. **Identify the role of self-awareness and emotional intelligence** in enhancing personal and professional well-being (PLO 4). Developing these skills will prepare you for professional success by fostering empathy, resilience, and adaptability—key traits valued in psychology-related careers.
 5. **Demonstrate the ability to discuss the importance of ethical and culturally sensitive practices** in psychology, establishing a foundation for later coursework on cultural competence and humility (PLO 5). This outcome will support you in crafting a career grounded in integrity and inclusivity, helping you set long-term goals for professional development and future education.

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom, which includes, but is not limited to:

- Taking an exam
- Participating in online labs
- Initiating contact with a faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 2. Asynchronous Courses: All class meetings are asynchronous.
 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
