Course Assignments

Assignment Category	Description	Percentage of Total Grade
Discussions	Each week you will participate in forums with the class in which you will discuss how, based on the weekly readings, you might address important, controversial topics with your congregation.	20%
Weekly Essays	At the end of each week, you will individually synthesize the week's readings and evaluate the church's role and/or responsibility with regard to the weekly topic.	50%
Final Essay	As the culminating assignment in this course, you will compose an essay in which you will examine the ethical implications of a real-world situation and discuss how the church and you, as a pastor, should respond.	30%

Synchronous Attendance/Participation Definition

Online Asynchronous Attendance/Participation Definition

Students taking online courses with no specific scheduled meeting times are expected to actively engage throughout each week of the course. Attendance is defined as participating in an academic activity within the online classroom which includes, but is not limited to:

- Engaging in an online discussion
- Submitting an assignment
- Taking an exam
- Participating in online labs
- Initiating contact with faculty member within the learning management system to discuss course content

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.

Course Modality Definitions

1. Online Courses: These are courses with class meetings where all instruction and interaction are fully online.
 1. Synchronous Courses: At least one class meeting takes place at a designated time.
 2. Asynchronous Courses: All class meetings are asynchronous.
 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).
