Criminal Justice Adult Degree Completion Purpose

The ADC – Criminal Justice program integrates specialized knowledge and skills with concepts of grace, restorative justice, and cultural competency which support the departmental mission to nurture servant scholars who critically evaluate social and cultural patterns and who constructively engage in society as agents of hope.

The ADC is designed to extend the PLNU mission to a new group of adult learners currently not served within the current traditional program. The focus will be on providing higher education in the context of a Christian worldview where minds are engaged and challenged and service in the criminal justice profession becomes an expression of faith. The curriculum works to enrich career opportunities through the integration of a focused educational program, a faith perspective, and a professional life.

Institutional Learning Outcomes

1. **Learning, Informed by our Faith in Christ**

Students will acquire knowledge of human cultures and the physical and natural world while developing skills and habits of the mind that foster lifelong learning.

2. **Growing, In a Christ-Centered Faith Community**

Students will develop a deeper and more informed understanding of others as they negotiate complex professional, environmental and social contexts.

3. **Serving, In a Context of Christian Faith**

Students will serve locally and/or globally in vocational and social settings.

Course Description

Designed to promote the capacity to respond to social and cultural realities of professional work in modern/diverse communities. Emphasizes an understanding of the interaction between CJ professionals and the public at the individual and community levels; ability to respond to diverse community demands and conflicts, such as responding to special-needs individuals, media inquiries, or using community-based policing. Examines methods that support the use of partnerships and problem-solving approaches to address the conditions that contribute to community safety issues such as crime, social disorder, and fear of crime.

1. Demonstrate and articulate an understanding of Community Policing. PLO 2
 2. Examine the roles CJ agencies and the community play in a robust social and community policing strategy. PLO 2
 3. Apply effective community interventions such as community-based policing; conflict resolution techniques to resolve issues within the community, or conflict management strategies to address between the members of the community and the criminal justice system or its representatives. PLOs 1, 2
 4. Examine the role and influence of mass communications such as traditional media, independent media, and social media. PLOs 2, 5

In SCJ 4003, we will cover a variety of topics, some of which you may find triggering. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on a discussion of a certain topic, know that you are still responsible for the material, but we can discuss if there are other methods for accessing that material and assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of Social and Community Policing, and I will support you throughout your learning in this course.

Incompletes and Late Assignments

All assignments are to be submitted by the due dates. There will be a 10% reduction of possible points for **each day** an assignment is late, and assignments will **not be** accepted for credit four days after the due date. If missing assignments result in the failure to meet learning outcomes, you may receive a letter grade reduction on the final grade in addition to the loss of points for missing work.
