Course Description

This course explores group interaction principles and processes and the necessary role of teams in the workplace. Students will be introduced to theoretical and practical concepts for understanding and analyzing group and organizational behavior. Additionally, students will practice and develop group communication skills while addressing topics such as group problem solving, group dynamics, and decision-making.

1. Evaluate knowledge of various group processes and their relationships to organizations. (PLO 1)
 2. Interpret a variety of group and organizational behavior tools to take effective action. (PLO 1)
 3. Analyze group development stages to determine the progress a group makes toward meeting its goal. (PLO 4)
 4. Identify the impact of personal values, personality, and knowledge in a group and organizational setting. (PLO 2)
 5. Define, differentiate, and apply group and organizational behavior concepts, theories, and principles. (PLO 5; PLO 1)

Program Learning Outcomes

The Point Loma Nazarene University RN-to-BSN graduate is prepared for expanded roles within his or her organization through enhanced abilities for:

The nursing student will integrate the ordinary work by complying with and adhering to regulatory and professional standards (e.g. ANA Code of Ethics, the California Board of Registered Nursing, Scope of Nursing Practice, SON Handbook). This includes taking responsibility, being accountable for all actions and treating others with respect and dignity.
 5. **Leading Faithfully** - The student will incorporate a foundational relationship with Christ and others and embrace a willingness to serve others in the midst of life circumstances (e.g., illness, injustice, poverty). The student will role-model the need for "Sabbath Rest" as a means of personal renewal, and true care of the self, so that service to others is optimally achieved. The student will incorporate the characteristics of a servant leader including: humility, courage, forgiveness, discernment.

PLNU Academic Accommodations Policy
