2. What could the ECLC staff do to make your experience more meaningful?

3. What suggestions would you offer for improvement?

- Maybe more training.
- Maybe more guidance in showing us what to do.
- Maybe gave an orientation with the 120 workers & the children to build respect.
- Pointers from teachers when communicating with children constructive criticism.
- I think just interacting more with us on the playground, giving us tips or pointing out P,S/E. or C observations.
- I did not find the training very helpful. I think instead, when a student arrives for their first day of field work a staff member should walk them through checking in and the logistics.
- Switch up the morning snacks.
- More feedback.
- I would suggest that the ECL C enforce consequences more for when a child does a wrong action.
- The training session in the beginning of the semester was helpful but too long.
- Step in when conflicts occur but lead field experience students in how to handle it.
- Sometimes it gets a little hectic with all the workers.
- Possibly being more flexible with times. I had a few issues with the timing of things that made it a bit hard to figure out sometimes.
- Make it required to do less hours.
- The ECLC staff couldn't do anything better that I would think of. They well prepared us and guided us.
- During my hours and observations, I did not see a whole lot of musical involvement, I feel like that could be beneficial.
- The teachers could help integrate the concepts in class to conversations had at the ECLC, such as Piaget's theories.
- I think that helpers should know more about the rules and schedules of the classroom before they begin their field experience hours.
- Less hours. This was a stressful time commitment.
- A more direct teaching moment on how to resolve conflict would have been helpful.
- One teacher seemed harsh to the kids and got easily frustrated.
- Ask the student workers to be more inclusive to the students doing field experience.
- Like I said before, I would love to be taught a little while interacting.
- It would have been nice to have fewer volunteers at the ECLC at any one time.
- Making the hours more accessible for someone with lots of commitments (like track.)
- Lessen the required hours. I was only able to go during chapel times so was at risk for paying chapel fines because of needing to work at the preschool.
- A shorter training time, a lot of the things were common knowledge & were repeated multiple times,

taking an excessively long time.

- To not have so many volunteers there at the same time.
- Maybe coach/instruct us what to do more.
- Giving the aides a warning that the kids might kick/spit at them.
- Maybe offer more help and examples when students get their hours signed off.
- For students to be able to have a more interactive role as opposed to just observing.
- Possibly an "in session" training in addition to the seminar.
- Not to have us cleanup & be little workers when we are supposed to be observing the kids.
- Have an extra teacher to explain things.
- Have an extra teacher explain things. (2nd student to leave same reply-verbatim)

- Teachers are more helpful to volunteers, give clear instructions.
- Maybe have a day of meeting the teachers and being introduced to the students.
