COURSE DESCRIPTION

This is an exciting upper level elective course that will integrate clinical medicine into the Pre-Medical Professionals learning through unique hands-on learning both in and out of the classroom. Students will have an opportunity to shadow providers both in the hospital setting and the clinical world depending on their placement. This course is designed to solidify interest in medicine while prepping heavily for graduate school and easing the transition to higher learning.

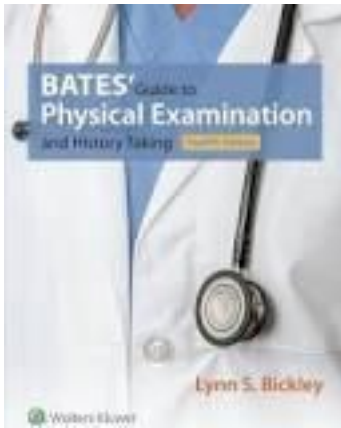
