Course Description

A first course in descriptive and inferential statistics for general students who have taken calculus. Topics include experimental design, sampling and sampling distributions, point estimation and hypothesis testing supported by the use of statistical software.

Learning Outcomes

- Students will be able to compute measures of central tendency for data.
- Students will be able to compute measures of dispersion for data.
- Students will be able to use statistical methods to make inferences from data.

Required Materials

- Calculator: A scientific calculator is recommended.

Homework

The homework will consist of doing the assigned checkpoints in the online modules along with written problems assigned as we go. Problems will always be due the next class meeting after being covered in class.

Examinations

There will be a midterm exam and a comprehensive Final exam. No examination shall be missed without an official excuse. A score of zero will be assigned for an exam that is missed without an official excuse. The [exam schedule](#) is included in the [daily schedule](#). I will not accept excuses such as poor communication with parents and/or travel agents.

Project

There will be a group research project to be described in class. Portions of the project will be due throughout the semester. This will give you experience applying the skills we have learned.

Other factors that affect grades are

- **Late work.** A written assignment or computer assignment is late if it is not received at the beginning of class on the due date. Late work need not be accepted. Work accepted late may be assessed a penalty. Make-up tests (or the exam) will be given only by arrangement with the instructor for reasons of documented emergency.
- **Questions on written assignments and exams:** Written assignments and test/exam questions and problems must be formulated carefully in terms of words and symbols used in the course. Credit is determined by the degree to which answers and solutions respond to the specific question or problem stated. Maximize your credit by learning the language and symbols of the course.
- **Format for Written Assignments.** Assignments collected must be prepared in a style suitable for grading. The following guidelines are used to determine credit:
 - the organization must be easy to follow
 - the work must be legible
 - complete solutions must be written for problems (not just answers); solutions must be clearly marked
 - use complete sentences to answer questions
- **Exams and Final Examination.** The Mid-Quad Exam and the Final Exam will include problems and questions over material assigned in the text, readings and handouts, as well as material presented in class.

Attendance:

Attendance is expected at each class session. In the event of an absence you are responsible for the material covered in class and the assignments given that day.

Regular and punctual attendance at all classes in which a student is registered is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements to be met. There are no allowed or excused absences except as approved in writing by the Provost for specific students participating in certain university-sanctioned activities. Excused absences still count toward the 10%-20% limits, but allow students to make up work, quizzes, or tests missed as a result of a university-sanctioned activity. Activities of a unique nature, such as labs or other activities identified clearly on the syllabus, cannot be made up except in rare instances when

instructors have given advanced, written approval for doing so. Whenever the number of accumulated absences in a class, for any cause, exceeds ten (10) percent of the total number of class meetings, the faculty member should send an e-mail to the student and the Vice Provost for Academic Administration (VPAA) warning of attendance jeopardy. If more than twenty (20) percent of the total number of class meetings is reported as missed, the faculty member or VPAA may initiate the student's de-enrollment from the course without further advanced notice to the student. If the date of de-enrollment is past the last date to withdraw from a class, the student will be assigned a grade of W or WF consistent with university policy in the Grading section of the catalog. There are no refunds for courses where a de-enrollment was processed.
