COURSE DESCRIPTION

Instruction and participation in the basic skills of surfing and rough water safety. Offered on a Quad basis.

COURSE LEARNING OUTCOMES

- 1) You will participate in learning the sport of surfing and a lifetime activity
- 2) You will learn beach and ocean safety including tides, wave height, wave interval, water temperature, rip currents (both temporary and fixed), surf etiquette, surf boards, leashes, wax, wetsuits and stinrays. And how each of these inform surfing conditions and decisions.
- 3) You will participate in the skills of surfing including paddeling, board position, truning turtle, sitting on your board, turning your board, catching waves (both whitewater and unbroken) and popping up.
- 4) You will self video and practice each week

COURSE CREDIT HOUR INFORMATION

The DRC's policies and procedures for assisting such students in the development of an appropriate academic adjustment plan (AP) allows PLNU to comply with Section 504 of the Rehabilitation Act and the Americans with Disabilities Act. Section 504 (a) prohibits discrimination against students with special needs and guarantees all qualified students equal access to and benefits of PLNU programs and activities. After the student files the required documentation, the DRC, in conjunction with the student, will develop an AP to meet that student's specific learning needs. The DRC will thereafter email the student's AP to all faculty who teach courses in which the student is enrolled each semester. The AP must be implemented in all such courses.

If students do not wish to avail themselves of some or all of the elements of their AP in a particular course, it is the responsibility of those students to notify their professor in that course. PLNU highly recommends that DRC students speak with their professors during the first two weeks of each semester about the applicability of their AP in that particular course and/or if they do not desire to take advantage of some or all of the elements of their AP in that course.

PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all synchronous class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions (virtual or face-to-face), the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation. In some courses, a portion of the credit hour content will be delivered asynchronously and attendance will be determined by submitting the assignments by the posted due dates.
