COURSE DESCRIPTION

This course provides an investigation and review of a wide variety of leadership concepts, practices and theories. Topics include the role of leadership in organizations, the historical examination of various leadership models, the contributions of leaders to a modern society, and an examination of biblical leadership. Emphasis will be placed on practical applications of leadership. The student should have defined a path of leadership for their future careers.

ROLE OF THE COURSE

The central theme of the leadership course is that there are a variety of factors that contribute to success in leadership. We will focus on three key topics facing leadership today, Globalization, Ethics, and Diversity. The overriding teaching objective is to focus your knowledge, skill, and abilities to "think as a leader" and to provide leadership when the opportunity presents itself. Upon completion of this course the student should be able to articulate a theory backed position on their view of leadership. Additionally leaders are often communicating a vison or an idea to others (followers), this course is designed to help students' practice and develop their communication skills by being assigned a topic to create and present in class.

This course should leave the student with the understanding and just as importantly the confidence to lead irrespective of title. A central theme will be understanding that we lead from any position in an organization's structure. It is also hoped that a developed understanding of leadership highlights the need to understand the value of following and followers. It should also stimulate the personal definition of what leadership character they define for themselves. Leadership is about recognizing opportunities and then choosing the proper behavior and course of action to bring about change. In the multitude of variables, weighing the ins and outs of leadership formulation and implementation forces the total person, who would be leader, to step forward and lead.

GENERAL INFORMATION AND REQUIREMENTS

Class Format:

This course is designed to provide a safe environment and opportunities for you to explore making decisions and preparing to move ahead in your career. It is designed to provide opportunities for discussion, enhancement, and experimentation. You should come to class prepared to participate in the discussion of the material.

Tuesday is lecture day. Review the material from the text/reading. Build a strong foundation of leadership theory, terminology, and applications.

Thursday is Group leadership work. Everyone will be assigned to a group. This will entail work and deliverables as a team throughout the course. Groups will meet to discuss reflection, material, and

literature review. This will consist of 30 minutes only. Team are excepted to be working on material outside of class as necessary. 2 students per Thursday class will be assigned to provide a brief Profile in Leadership presentation.

Any use of technology in the class is to be exclusive to the class or related note taking. No phone use will be allowed whatsoever. Computer usage is highly discouraged. If issues arise from use of devices, I will implement a ban on devices during all lectures and presentation.

Materials:

Students should come to class prepared to accomplish work done digitally and using the course management software provided by the university if needed. All material handed in should be able to be accessed using PC software if possible.

Assignments:

Assignments are due as scheduled and must reflect a professional format. Therefore, all assignments must be turned posted in APA format. APA guidelines may be purchased at the bookstore or referred to in the library.

Late Policy:

All assignments as scheduled unless otherwise announced. No late assignments (including tests) will be accepted unless the instructor has given approval prior to the due date and a new completion date and consequences have been agreed upon. This arrangement should be made only under extreme circumstances.

Make up quizzes will not be given.

Make up exams will not be given.

Responsibilities:

Each student is responsible for his or her own work and learning. Each student is responsible for assignments or other announcements made in class. Each student is responsible for checking and using the university email system and the university course management software (Canvas) I will not tell you what to write down.

COLLABORATIVE LEARNING

The grading of individuals in a group-learning situation. While collaborative learning is sometimes graded only based on what the group produces, at times individual grades are given in this setting. When this latter scenario is the case, students within a group will be graded and these grades may be seen by the other members of the group. As such, students are forewarned and the institution/instructor is protected.

SHARED POWER POINT SLIDES

The electronic posting of Power Point presentations (one's personal property, in a sense), is sometimes required as part of the class. Students should be aware of this fact.

Specific Requirements/Assignments

1. Profile in Leadership Presentation (50pts.)

Each student will be required to read assigned chapter in Soul Survivor. They will be required to present a 10-minute review of the leader they are assigned. The presentation will be to the class and a quasi-formal approach. Every week two students will be presenting on the same profile of a leader. Their leadership story needs to be translated to the student's real-world experience or a reference for their developing leadership style.

2. Quizzes: (150 pts.)

In order to pass this class you must demonstrate competency with the material found in the text. You must pass with a significant score on the 15 chapter quizzes given over the text material.

Please note: Seldom are grades determined by one or two big point totals, positive or negative, but are an accumulation of the body of work over a semester. Such is the case in the working world – seldom does an extraordinary day or a disastrous one make or ruin a career – it is the discipline of doing the best over time that is valued.

3. Reflections: (150 pts.)

Reflections are done by Team, however every team member must, I will be giving special attention to monitoring the submission for inclusion from every team member.

Leadership is not done in a vacuum. Reflections must include each members thoughts and an updating on their current status. Grading is done as a team and the contribution of a single member can be impact the grade of the team. Leadership will ensure all the members of the team contribute to the final result.

4. Participation/Attendance: (150 pts.)

Class participation is different from attendance. Attendance is showing up for class. You will be required to participate in class with questions asked about the current reading assignments, the text, and current events. You will need to take the initiative and lead in contributing to the discussions.

You are required to arrive at class prepared and ready to fully engage. Your leadership will be defined by your preparation in advance. As a leader or a follower, you must engage and share.

Engagement:

You are expected to come prepared to every class session and to actively participate in class discussions.

- You are required to reflect upon and state you current status in relation to:.
- 1. The current reading, text and class.
- 2. Comments on the Research presented.
- 3. Activities and Exercises performed in/for class.
- 4. Current status of the reading of the assigned books.
- 5. Status of the Team.
- Your approach should be from a leadership perspective How am I doing? What am I doing? Where is it being done?
- You may be asked to speak to any issue from the reflections during the next class. You should be prepared to respond. Notes are appropriate but extensive use of notes to answer questions detracts from the response.

• Reflections are based upon the material and the work in the class just finished.

5. Midterm Exam: (150 pts.)

Date TBD. Test questions taken from text material. To be administered in class.

6. Final Written Project: (200 pts.)

You will be required to turn in a Final Written Project. Written as a Team and turned in for a Team grade. The paper requires the Team to blend examples, from the text Soul Survivor, and Turn the Ship Around, to explain the Model of Leadership studied in this class. You should approach the writing of the Project to demonstrate your understanding of the totality of your understanding of leadership. Through your educational experience you have studied, seen, and experienced leadership in many shapes and forms. The Project should include all you know and compare your experiences and knowledge with that exhibited in the 3 non-text books each has read. It must demonstrate your insight and expertise on the topic of Leadership from the multiple sources used in class.

This Project should be done in 4-8 pages excluding title, toc, reference pages.

7. Final Exam: (150 pts.)

Given at the end of the course to assess the value added of the material in this course.
