

Happy new year and welcome to BIO6021-2. Our main goal is to study why health and life expectancy has improved so much over the past 150 years. Why bother with this, since it is history so to speak? Well, perhaps there are several notable reasons. First, this type of study can give us much insight into human biology, since we are studying the biological vulnerabilities which have been protected or

overcome. Second, almost all the societal, public health, and medical measures require constant maintenance and adjustment in order not to lose the benefits which we have gained. Third, one can gain a sense of gratitude for all that is done to protect us. Fourth, there can be a sense of responsibility to further support these efforts. As cooperative members of society, we may have already made important contributions to the health and longevity of those around us. Finally, one can perhaps better appreciate that, in general, it is a good time to be alive on earth.

COURSE DESCRIPTION

Special topics courses are offered occasionally to focus on a topic of interest, or to teach a course for the first time. This semester, the special topics course will focus on Health & Human Biology. This is a graduate course that will concentrate on the reading, understanding, and presentation of relevant journal articles, websites, and government documents. The subject area will be the main public heath, societal, and medical measures which were introduced over the past 150 years to improve human health and longevity as well as some relevant diseases and conditions. The current difficulties with extending human longevity will be explored.

Course logistics: Synchronous zoom sessions will be on Wednesdays from 5:30-6:30 PM approximately every 2 weeks. Please be aware that during the second half of the course some schedule changes will need to be mutually agreed upon. These changes will be made so that some students may also take the Wednesday night lab course in cell biology.

Since this is a one-unit course and meets on average every two weeks for one hour, it is expected that 5 hours of preparatory work/assignments will be required before each session. In other words, the average amount of time on activities related to the course would be 3 hours per week reading, writing, preparing, and attending.

COURSE LEARNING OUTCOMES

- 1. By the end of the course the student should be able to explain the complementary nature of the public health system and medical system in the US.
- 2. The student will be able to summarize the more important underlying biological determinants of world and US health, including key globally important diseases.
- 3. The student will be able to explain how life expectancy has doubled and human health greatly improved over the past 150 years by identifying the main improvements in public health, societal organization, and medical care that most affect overall health.
- 4. The student will have examined the challenges to continued improvement in health in the face of recent mild decreases in US longevity despite continuing medical advances.
- 5. The student will have a knowledge basis for developing ways to think about how best to maintain and improve our general population health.

REQUIRED TEXTS AND RECOMMENDED STUDY RESOURCES

Open access course materials, no textbook: There will be articles or websites to review for each of the assignments and class sessions. Purchase of a textbook is not necessary.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1 unit class delivered over 15 weeks. Specific details about how the class meets the credit hour requirement can be provided upon request. (Based on 37.5 hours of student engagement per credit hour.)

ASSESSMENT AND GRADING

Before each zoom session, submit a list of main points for each reading, as well as generate discussion questions for each reading. These assignments are due at midnight, prior to the zoom session in which these particular readings are to be discussed. The purpose of the main/interesting points is to focus and reinforce the reading. These may each be produced with a single sentence. The questions you generate from this assignment may be used to direct your own further explorations of the subject or to use during the zoom sessions. They can also be approached during office hours.

For each zoom session, each student/student group will lead the discussion of one reading or a section of one reading. In general, the student or student group will use slides to aid in introducing the discussion. Two to five slides will generally suffice. All students need to show good knowledge of the background materials discussed during the session.

The course is pass/fail. Under most circumstances, to obtain a passing grade all assignments must be completed and classes attended. In case of emergencies or sickness, substitute assignments will be given and/or sessions scheduled. Please notify me before the synchronous zoom class session to be missed, if at all possible. The maximum number of missed synchronous zoom sessions under all circumstances is two. In the case of one or two excused absences, points will be lost and will need to be made up with extra assignments. Missing three of the synchronous sessions results in no credit for the course. Since this is a graduate course, the other criterion for passing is to obtain a percentage which corresponds to a C or better, that is, 73% or better.

There is no final exam for this course.
