## COURSE DESCRIPTION

Introduces techniques of emergency care as outlined by the Emergency Medical Services Education Standards (NAEMSES). Provides the theoretical portion of the EMS standards, designed to prepare graduates to work in prehospital care (ambulance, firefighter) and emergency departments at EMT basic level.

## **COURSE LEARNING OUTCOMES**

1. To provide the student with an understanding of the role of an EMT-B as determined by State and County guidelines, medical legal limitations, and the roles of other pre-hospital care providers within the EMS system.
2. To enhance the student's ability to communicate effectively with medical personnel through the introduction of basic, descriptive medical terminology.
3. To increase the student's understanding of basic anatomy and physiology of major body systems as it relates to emergency care for associated illnesses and injuries.
4. To develop the student's skill in performing efficient patient assessment techniques in order to determine appropriate field intervention and provide effective patient monitoring.
5. To develop the student's ability to recognize life threatening emergencies and institute appropriate field intervention based on triage priorities.
6. To increase the student's knowledge of efficient stabilization and extrication measures aimed at prevention of further injury to a patient prior to transportation to a medical facility.
7. To increase the student's effectiveness in dealing with special medical problems such as those presented by pediatric and psychiatric patients.
8. To enhance the student's ability to deal with the public during times of stress in the pre-hospital care environment.
9. To provide the student with an opportunity to observe the course of illness and injury from onset to definitive hospital care.

## **CLASS HOURS**

The KIN1002 portion of the class will be held from the dates and times stated above. Class will begin promptly at the designated time and excessive tardiness will not be accepted. Speak to the instructor if you have a scheduling conflict. **Anyone who leaves early without permission may be counted absent** for that class session. Additionally, there is an EMT ambulance ride-along (24 hours), which fall outside of the listed class hours.

Contact Ron Ungar and wait for further instruction in the unlikely event that an instructor is not present at the beginning of class. Do not assume class is cancelled unless a PLNU Instructor or staff member advises you of that directive.

- If you are late the highest you can score on a quiz is 80%
- Will be multiple-choice and administered via canvas
- Quizzes will **not** be made up if absent. I will drop your lowest score in each course

## **Manipulative Skills Examination at the end of EMT 113L**

- Each skill will be pass/fail according to your Skills Manual. Any student who does not pass the skills final will not receive a course completion certificate and will not be eligible to take the NREMT Certifying (Written) Exam.
- The skills exam will be administered as part of your course during the finals week of the semester. You must bring a bystander, age 18 or older, who is able to stay for the entire testing process. If you do not bring a bystander, you may not be allowed to test. Test Coordinator is TBA.

- Additionally, a completed BLS Skills Sign-Off Sheet (provided in class) must be turned in on the day of the Skills Examination to receive your Course Completion.

## COURSE REQUIREMENTS

### Fees

There is a \$100 fee for the National Registry Skills Exam (at the end of KIN2003. More information will be distributed later in the course.

Students will be issued a PLNU EMT shirt when the instructors feel it is the right time. You will wear this in class as well as for the Emergency Department (clinical) observation and ambulance ride-a-long(s). The cost of the shirt and other issued EMS equipment are covered as part of your material fees.

### Ambulance Ride-a-long 24 hours

1. Required for completion of KIN1003  
Sign-up will take place during class. Students must wear their PLNU EMT shirt, dark pants & Hard shoes.
2. Any student who fails to complete an Ambulance Ride-along, or fails to document 10 patient contacts in their packet will receive an "Incomplete" grade and will not receive a Course Completion certificate. Packets will be handed out in class and must be turned in by the end of the semester.

Note: You may not sign up for your Ambulance Ride-a-long on a day that you are normally scheduled to be in class, including additional skills Saturdays. Please check the Class Schedule before signing up for these experiences.

### EMT Certification Testing

You must create a login and submit an application to [www.nremt.org](http://www.nremt.org) prior to the Skills Examination in order to receive your Course Completion and be eligible to take the written National Registry Exam. The class written final is not the National Registry Exam. Certification testing will take place at Pearson VUE Testing Center, and you must have the following documents to enroll:

1. Current CPR Card: AHA HCP or ARC Professional Rescuer
2. EMT Course Completion Certificate
3. Cost: about \$80. Signup will be done online by the student. More information will be given to the student at the end of the semester.

There are third party online companies (such as Fisdap.net) that offer preparatory services (such as practice exams and study guides) for the NREMT written exam. Although we do not recommend one company over another, your instructors do recommend that you investigate purchasing one of these services to assist you to prepare for your written exam Note: Certification may be denied if you have a criminal record. determination will be made by the County of San Diego EMS Office.

## **STATE AUTHORIZATION**

State authorization is a formal determination by a state that Point Loma Nazarene University is approved to conduct activities regulated by that state. In certain states outside California, Point Loma Nazarene University is not authorized to enroll online (distance education) students. If a student moves to another state after admission to the program and/or enrollment in an online course, continuation within the program and/or course will depend on whether Point Loma Nazarene University is authorized to offer distance education courses in that state. ## **PLNU ACADEMIC ACCOMMODATIONS POLICY**

While all students are expected to meet the minimum standards for completion of this course as established by the instructor, students with disabilities may require academic adjustments, modifications or auxiliary aids/services. ## **PLNU ATTENDANCE AND PARTICIPATION POLICY**

Regular and punctual attendance at all synchronous class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions (virtual or face-to-face), the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation. In some courses, a portion of the credit hour content will be delivered asynchronously and attendance will be determined by submitting the assignments by the posted due dates.
