### **COURSE CREDIT HOUR INFORMATION**

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 2 unit class delivered over 8weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 75 total hours meeting the course learning outcomes. The time estimations are provided in the Canvas modules.

#### **PROMPTS**

### Assignment #1: Disability Visibility chapter

Taking inspiration from *Disability Visibility*, an anthology of essays edited by Alice Wong, craft a personal narrative of 1,500 – 2,000 words in alignment with one of the four sections of the book: Being, Belonging, Doing, and Connecting. You may interpret these terms in any way you'd like. Your essay should, in Wong's words, "show Disabled people simple being in [their] own words, by [their] own accounts" (xx, emphasis original). This is your account.

### **Assignment #2: Podcast Episode**

For this assignment, you will produce and host a podcast episode for the "Disability Belongs" podcast. Your episode should examine one of the course texts from a new angle, infusing your analysis with your personal experience. The episode should reflect a high degree of professionalism and knowledge of the subject matter.

### **Assignment #3: Research Paper**

In a 10-page research paper (not including Works Cited), you will craft a research-based argument that critically analyzes all three course texts and examines their social, cultural, ethnic, gendered, and/or historical context. This argument should contribute a novel insight into the discourse of Disability literature and its impact in 21<sup>st</sup> century Western culture. Your analysis could describe a problem that needs rectifying or a cultural development that needs more awareness or a gap in the literature or any other research-based angle you'd like to pursue.
