COURSE DESCRIPTION

This capstone course provides an in-depth study of contemporary critical trends such as Structuralism, New Historicism, Feminism, Deconstruction, Gender Studies, Reader-Response, and Psychoanalytic criticism. Students also familiarize themselves with the critical commonplaces to which these new approaches are a response as well as with a traditional overview of trends and styles from medieval through modern literature. Students are expected to engage in some research and in written critical work. Preparation of a portfolio and summative evaluation is an important part of this class.

COURSE LEARNING OUTCOMES

At the Conclusion of the Course Students will be able to:

1. Closely read and critically analyze texts in their original languages and/or in translation.
2. Recall, identify, and use fundamental concepts of literary study to read and discuss texts
 - a. Standard literary terminology
 - b. Modes/genres of literature
 - c. Elements of literary genres
 - d. Literary periods (dates, writers, characteristics, and important developments)
 - e. Contemporary critical approaches
 - f. Extra-literary research
3. Analyze the social, cultural, ethnic, gendered, and/or historical contexts of the works and their authors, and connect the texts with their own lives.
4. Create detailed and informed textual analysis of literary works that examine several of the fundamental concepts of literary study.

COURSE REQUIRMENTS

Presentation Notes: Five times during the semester, each of you will lead a discussion of the assigned reading. At the end of the class session, I will collect the notes you used to prepare for the discussion.

Analytical Essay: “The Turn of the Screw” Essay: Each of you will complete a 3-4 page essay in response to “The Turn of the Screw” by Henry James.

Professional Preparation: Each of you will develop a personal website and other professional documents.

Assessment Portfolio Assignments:

- Research Paper: The major assignment of the semester is a 10-12 page analytical paper on *Gone Girl*. The paper will follow MLA format and use a critical-theoretical approach or approaches presented in Ryan’s book. The essay will include your own analysis, theoretical grounding, research, and critical engagement with your sources.

Regular and punctual attendance at all **synchronous** class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions (virtual or face-to-face), the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation. In some courses, a portion of the credit hour content will be delivered **asynchronously** and attendance will be determined by submitting the assignments by the posted due dates.
