COURSE DESCRIPTION

This course examines the concepts and applied techniques for cost-effective management of projects. Key topics of focus include developing a project plan and scheduling resources, work breakdown structures, and project networks. This course also examines the current philosophies of leadership as applied to project management and identifies various styles of communication and conflict resolutions essential to project team leadership. Through case studies and various exercises, the student will develop enhanced leadership, communication, conflict management, and negotiation skills essential to project management.

<u>Eight Homework Assignments (80%):</u> Homework assignments are listed in Canvas. There are 8 of them worth 800 points in total. They are due at the end of Weeks 2, 4, 6, 8, 10, 12, 14 and 15.

<u>Project Plan (10%)</u> due May 5, 2023 - is a course long individual assignment concerning the project planning process from either the POM+ case study. We will introduce and use Microsoft Project, as well as RUF to build a Project Plan. The submission will follow the Project Plan template from RUF as to content and style. APA is not needed. Software planning documents will be used as attachments. This is an Assessment Assignment and does require particular attention to submission details. A detailed rubric will be attached to the assignment in Canvas.

Please prepare a project plan overview and proposal for the executive, C-Level staff. Include the goals, necessary business case, resources required, team composition, planned schedule, risks and intended metrics for success. Detail what will be done, who will do it and when results will be achieved. Address why the project benefits the strategic positioning of the firm or organization, as well as how success can be recognized and measured. Write the proposal as if it was your firm's method to gain executive approval for a project. Please use up to 6-single-spaced pages. Most are 2-3 pages. Think of this as a business proposal to the executive staff or financial backers. Make the business case for your success.

This need not be in APA format but please use 12-pitch font and acknowledge references in the text of the write-up. Please follow the flow described in *Risk Up Front* for project planning as detailed in the Appendix of the book.

Specifically, please prepare a project plan overview and proposal for the executive, C-Level staff. Include the goals, necessary business case, resources required, team composition, planned schedule, and intended metrics for success.

- 1. As an introduction, detail what will be done, who will do it and when results will be achieved.
- 2. Address why the project benefits the strategic positioning of the firm or organization, as well as how success can be recognized and measured.
- 3. Write the proposal as if it was your firm's method to gain executive approval for a project using the information and data from the POM+ case.
- 4. Please use up to 6-single spaced pages. Think of this as a business proposal and project plan to the executive staff or financial backers. Use any required templates or forms as Appendices.

The assignment will be graded with the following criteria:

- 1. Are the project's purpose, goal(s), assumptions, scope, sponsor, stakeholders and team members identified as to roles and responsibilities?
- 2. Are the deliverables for the project specified as to time, cost and quality standards?
- 3. Are all project tasks identified?
- 4. Is there a clear schedule as to start, end, critical path and resource leveling?
- 5. Is the budget and business case explained with cost estimates?
- 6. Are factors and measures for success identified?
- 7. What aspects of the project will be at risk?
- 8. Please conclude with a short, 250-word summary that create a compelling argument.

The in class assignment (10%) Final Exam- The final will be a case analysis which will be provided before class focused on Scrum Project Management. The focus will be analysis of team dynamics and selection of resolutions using the project management and team lessons from Larson and Gray. The exam will be open source.
