

COURSE DESCRIPTION

An introduction to the functions necessary for the study of calculus with an emphasis on numerical and graphical notions of continuity, limits, and derivatives. The following function types are used as examples for the study of the concepts: polynomial, rational, exponential, logarithmic, and trigonometric functions.

COURSE LEARNING OUTCOMES

- 1. Students will develop an ability to graph functions including polynomial and trigonometric functions.
- 2. Students will develop an ability to solve problems using polynomial, exponential, and trigonometric functions.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 3-unit class delivered over fifteen weeks. ASSESSMENT AND GRADING

Graded Components

- **Homework**: Homework problems will be assigned regularly and posted on Canvas. A homework assignment is late if it is not submitted at the beginning of class on the due date. Please check regularly to ensure that you are keeping up with the homework. Late homework will not be accepted. Your lowest two homework scores will be dropped.
- Quizzes: Quizzes will be given at the beginning of class time, so please try to be in your seat before the class period begins (less disruption to others). Quizzes are designed to take no more than five minutes to complete. However, ten to fifteen minutes of class time are set aside to complete these activities. Quiz dates are set in advance and are listed on the class calendar. During the course, you may find that you must be absent the day of a quiz due to a personal situation. For this reason, you are allowed to drop your two lowest quiz scores. There will be no make-up quizzes, no exceptions, so use your dropped quizzes wisely.
- Examinations and the Final Examination. Examinations and the Final Examination will include problems and questions over material assigned in the text, readings and handouts, as well as material presented in class. No examination shall be missed without a well-documented emergency beyond your control. A score of zero will be assigned for an examination that is missed without a well-documented emergency beyond your control.
- Late work will not be accepted. Homework assignments that are submitted late will be recorded with a score of zero. During the course, you may find that you are unable to submit homework on time due to a personal situation (for example, a personal or family illness, accident, business trip, etc.). For this reason, if more than half of the homework assignments are submitted on time, then the lowest two homework scores will be dropped from the calculations of the homework grade. There are not exceptions to this policy so please use your dropped assignments wisely.

FINAL EXAM:

The final exam date and time is set by the university at the beginning of the semester and may not be changed by the instructor. This schedule can be found on the university website and in the course calendar. No requests for early examinations will be approved. Only in the case that a student is required to take three exams during the same day of finals week, is an instructor authorized to consider changing the exam date and time for that particular student.

Grading Scale

Grades are based on the number of points accumulated throughout the course with the following exception. A student must pass at least one of Examination 1, Examination 2, or the Final Examination in order to pass the class. That is, a score of 60% must be achieved on one of the Examinations, or else the final grade will be an F regardless of all other point totals. Approximate minimal percentages required to obtain a given grade are:

STATE AUTHORIZATION

State authorization is a formal determination by a state that Point Loma Nazarene University is approved to conduct activities regulated by that state. In certain states outside California, Point Loma Nazarene University is not authorized to enroll online (distance education)

students. If a student moves to another state after admission to the program and/or enrollment in an online course, continuation within the program and/or course will depend on whether Point Loma Nazarene University is authorized to offer distance education courses in that state. It is the student's responsibility to notify the institution of any change in his or her physical location. INCOMPLETES AND LATE ASSIGNMENTS

All assignments are to be submitted/turned in by the beginning of the class session when they are due—including assignments posted in Canvas. Incompletes will only be assigned in extremely unusual circumstances.

CLASS ENROLLMENT

It is the student's responsibility to maintain his/her class schedule. Should the need arise to drop this course (personal emergencies, poor performance, etc.), the student has the responsibility to follow through (provided the drop date meets the stated calendar deadline established by the university), not the instructor. Simply ceasing to attend this course or failing to follow through to arrange for a change of registration (drop/add) may easily result in a grade of F on the official transcript.
