## **COURSE DESCRIPTION**

A calculus course intended for those studying business, economics, or other related business majors. This course covers differential and integral calculus of elementary functions with an emphasis on business applications. This is a brief calculus course and not appropriate for students majoring in science, computer science or mathematics.

# **Graded Components**

- **Homework**: Homework problems will be assigned regularly and posted on Canvas. A homework assignment is late if it is not submitted at the beginning of class on the due date. Please check regularly to ensure that you are keeping up with the homework. Late homework will not be accepted. Your lowest two homework scores will be dropped.
- Classwork: We will regularly have activity worksheets that are to be worked on collectively during class. If you finish them during class time you may turn them in, but you won't always be able to finish them within the allotted time. You may continue to work on them during the week, and they are due by the next class period.
- Examinations and the Final Examination. Examinations and the Final Examination will include problems and questions over material assigned in the text, readings and handouts, as well as material presented in class. No examination shall be missed without a well-documented emergency beyond your control. A score of zero will be assigned for an examination that is missed without a well-documented emergency beyond your control.
- Late work will not be accepted. Homework assignments that are submitted late will be recorded with a score of zero. During the course, you may find that you are unable to submit homework on time due to a personal situation (for example, a personal or family illness, accident, business trip, etc.). For this reason, if more than half of the homework assignments are submitted on time, then the lowest two homework scores will be dropped from the calculations of the homework grade. There are no exceptions to this policy so please use your dropped assignments wisely.

## **FINAL EXAM:**

The final exam date and time is set by the university at the beginning of the semester and may not be changed by the instructor. Only in the case that a student is required to take three exams during the same day of finals week, is an instructor authorized to consider changing the exam date and time for that particular student.

# **Grading Scale**

Grades are based on the number of points accumulated throughout the course with the following exception. A student must pass at least one of Examination 1, Examination 2, or the Final Examination in order to pass the class. That is, a score of 60% must be achieved on one of the Examinations, or else the final grade will be an F regardless of all other point totals. ## **CLASS ENROLLMENT**
