**Conclusions Drawn from Data:**

This was the third year that students completed this assessment as part of the Senior Seminar course. Students are still meeting and exceeding the benchmarks in all categories. The 2022 decline in several datapoints was likely because we did not do an adequate job making clear the expectations of the

assignment we gave them in the Seminar course. We believe the rebound in the numbers this year was due in part to explaining the assignment better to the class.

**Changes to be Made Based on Data:**

The professor of the Senior Seminar course needs to continue to be clear about the expectations regarding this assignment. Rather than just giving the students the assignment, we need to walk them through the details. Continue to have in-person discussions with our students about the “why” behind a video résumé. Otherwise, no changes at this time, other than to collect and monitor the longitudinal data.
