Face-to-Face MBA/MAOL Courses:

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled

# 1-Unit Online Evening MBA/MAOL Courses:
