COURSE DESCRIPTION

This course examines leaders from diverse backgrounds as models for students to develop their ability to lead with integrity and purpose. Students will be challenged to integrate their academic knowledge, core values, and experiences as it relates to leadership. Students will craft a personal leadership development plan and have the opportunity to participate in a service project.

1. Discover influences that impact the development of integrity and character in one's personal and professional life (PLO 1 & 5).
2. Examine the role that virtues and ethical decision-making play when leading with integrity (PLO 5).
3. Apply leadership principles in a service setting (PLO 5).
4. Identify and discuss the rationale and benefits of incorporating service to others as an integral part of leadership (PLO 1 & 5).
5. Examines one purpose as it relates to both personal and professional life (PLO 5).
6. Construct a leadership development plan (PLO 1 & 5).

CLASS FORMAT

This class is uniquely broken up into 6 days classes. Through the 6 classes, we will have different speakers, readings and assignments for students to engage in. In addition, we will spend a good deal of time in discussion on the subjects of purpose, integrity and service.

Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of [subject/major], and I will support you throughout your learning in this course.

COURSE MODALITY DEFINITIONS

1-Unit Online Evening MBA/MAOL Courses:
