ASSESSMENTS AND GRADING

Your grade is based on the following areas of work:

PTV News (250 points): Students will contribute to the production of five video newscasts. Video newscasts will be assessed for a total of 25% of the final grade.

Heynouncements (100 points): Students will contribute to the production of four Heynouncement videos. Heynouncements will be assessed for a total of 10% of the final grade.

Original TV Show (200 points): Students will contribute to the production of an original television program. The production will be assessed for a total of 20% of the final grade.

Original Short Film (200 points): Students will contribute to the production of an original short film. The production will be assessed for a total of 20% of the final grade.

Project Lead (100 points): Each student will perform the role of project lead at least once. Performance in this role will be assessed for a total of 10% of the final grade.

Project Evaluations (100 points): Each student will submit self-evaluations and group evaluations for the productions completed during the course. Evaluations will be assessed for a total of 10% of the final grade.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1 unit class delivered over 15 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 37.5 total hours meeting the course learning outcomes. The time estimations are provided in the Canvas modules.

INCOMPLETES AND LATE ASSIGNMENTS

All assignments are to be submitted/turned in by the deadline associated with each assignment in Canvas. Incompletes will only be assigned in extremely unusual circumstances.
