#### **COURSE DESCRIPTION**

This course provides a study of the financial planning process, including an individual's lifelong saving, borrowing and investment decisions. Topics include cash management, consumer loans, debt and credit management, investments in stocks, bonds, mutual funds and ETFs, real estate, insurance and risk management, budgeting, retirement, tax and estate planning.

## Additional information regarding graded events:

- a. <u>Discussion Questions:</u> The Discussion Question assignments may be a combination of Canvas-based discussions and in-class discussions. In-class discussions may be verbal or written, depending on the topic. Further guidance will be provided for each discussion topic.
- b. <u>Participation</u>: Participation grading will be based on your attendance <u>and</u> <u>participation</u> in class sessions. The general premise is that you participate at the level to achieve your earned grade. These are NOT free points.
- c. **Quizzes**: There will be quizzes during the semester consisting of multiple choice and true/false questions. Such quizzes will be given at the beginning of the class period and students must be present in class to take the quiz.
- d. *Murphy Minute Discussions*: There will be a short video posted in Canvas some weeks in which I will discuss something related to recent events in the market. You will be required to make comments reflecting your view or understanding of the topic. This may require knowledge sources not in the textbook or involve your personal knowledge or experience about a topic.

- e. <u>Homework Assignments</u>: There will be Homework Assignments that will be completed using the Cengage platform. The specific Homework Assignments, as well as the due date/time for each, will be posted via Canvas. Late Homework Assignments will not be accepted as I may review all assignments in class immediately after each assignment is due. Submit only your own original work for Homework Assignments. Homework Assignments will be completed on Cengage platform or prepared using Microsoft Excel and/or Microsoft Word) and submitted through Canvas.
- f. <u>Team Video Presentation:</u> Students will create a video of a session that will simulate a dialog among a group of financial planners (you) addressing issues from a profile you will be given. Each video session/presentation will be created as a team of 4-5 students. The video will consist of team dialog around issues and finish with a summary of findings & recommendations. More details will be provided in class. The grading will be based on the presentation content, delivery, and interim deliverables prior to the presentation. While teamwork will affect the grade, grading may be done individually based on the quality of each student's work.
- g. **Exam:** There will be a late-term exam. The exam will cover all material covered prior to the exam.
- h. **Bonus Points:** 10 bonus points will be awarded for no apparent reason (but see below).
- i. **No Dropped Grades:** There will be no dropping of the lowest HW or quiz grades or any other grades.
