# **COURSE DESCRIPTION**

This course focuses on the integration of advanced health assessment principles and skills for comprehensive physical assessment across the lifespan. Emphasis will be on comprehensive and focused health history, advanced physical assessment of body systems, psychosocial assessment, differentiation of assessment findings, and assessment documentation. Incorporation of developmental, psychosocial, spiritual, and functional assessment will be included. Letter Grade

- In order to receive a passing grade in a GNSG course, the student must achieve a cumulative average of 81% on exams and quizzes.
- Students who achieve less than 81% in a GNSG course must repeat the course in order to progress in the program.

#### **TRIGGER WARNING**

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In GNSG 6008 Advance Health Assessment and Health Promotion Across the Lifespan, we will cover a variety of topics, some of which you may find triggering. These topics include topics of health assessment reviewing each body system, spiritual assessment, cultural assessment, and mental health assessment. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experience of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of advanced health assessment and health promotion, and I will support you throughout your learning in this course.
