- Narrative Review: As part of an effort to gain experience in biomechanics scientific research, each student will be required to complete a literature review on a topic within the fields of sports biomechanics, physical therapy, or gait analysis. This project involves searching and reviewing six biomechanical research articles from peerreviewed journals relevant to their selected topic and writing up a three-page abstract summarizing their analysis of the topic.
- In-Video Quizzes: All module lectures will be shown through weekly in-video quizzes, which are interactive videos each embedded with 3-5 questions relevant to the content. If you do not complete any in-video quizzes, you receive 0 points for that module.
- Participation: In addition to the live class sessions and the syllabus quiz, participation will be measured using module discussions that require you to post a response to the prompt and replies to at least two of your peers. Your posts should be substantive in nature and foster a healthy dialogue between peers about the material. Your initial post should be at least 250 words while replies to peers should be at least 100 words. In some
