NSG 4061 Nursing of Communities: Community Health Clinical Practicum (1 unit) Application of the nursing process to individuals, families, and communities using the concepts studied in NSG 4060 Community Health Focus. Students work with families in a variety of community based settings including a health department. Graded Credit/No Credit.

ASSESSMENT AND GRADING

Students will receive a "Credit" or "No Credit" grade for each clinical course. The "Credit" grade is passing or satisfactory; the "No Credit" is not passing.

Clinical Performance Evaluation

The Clinical Performance Evaluation (CPE) form is designed to evaluate students' performance during clinical courses and to highlight areas in which the students are progressing satisfactorily as well as areas that require improvement. The clinical preceptor/faculty will use this evaluation tool for both midterm and end of course evaluations of students in clinical practice. The student will rate themselves first, prior to giving the form to the clinical preceptor/faculty who will then rate the student. Both will review the form together to generate discussion and future performance goals. Both midterm and end of course evaluations will occur on the same form.

Midterm Assessment. The student and preceptor will review the form together to discuss each core competency and jointly rate the student's performance. With faculty, the student will then review the feedback and develop a plan for improvement regarding any areas that were rated as "Below Expectations" or "Does Not Meet Expectations".

Final Evaluation results in a clinical **grade** of either Credit or No Credit. Clinical performance is evaluated using the listed core competencies that mirror the Quality & Safety Education for Nurses (2003) competencies. Students must earn a minimum of 75% of the total possible competency points in order to receive a passing grade. A competency rating of "Does Not Meet Expectations" (i.e. rating of 1), upon final course evaluation, may result in clinical failure (grade of NC).

Fall Pre-Season and Spring Training

Prior to the start of clinical in the fall and spring semesters, Juniors and Seniors are required to participate in clinical skills and judgment practice and testing. The purpose of these mandatory training sessions is to validate students' ability to perform essential clinical skills prior to patient care. Students must pass the medication calculation exam (93%) and the medication administration competency in order to pass medications in clinical.

If a student is not successful in passing the medication calculation exam or the medication administration skill, they will need to remediate and retest. The need for a second attempt of either competency will require the initiation of a Learning Plan. The need for a third attempt will require the initiation of a Performance Improvement Plan. Those who do not successfully complete a third attempt will be put on Probation.

Required Clinical Modules

Students are required to complete specific modules per PLNU, the San Diego Nursing Education Consortium, and their specific assigned clinical agency before they can begin their clinical rotation. Failure to complete these modules on time can delay the student and/or their entire clinical group from beginning their rotation. Late completion may also require the initiation of the Corrective Action Process.

TRIGGER WARNING

I acknowledge that each of you comes to PLNU with your own unique life experiences. This contributes to the way you perceive several types of information. In *Nursing of*

Communities: Population Health Clinical Practicum, you will encounter various difficult patient situations, some of which you may find triggering. These situations may include discussion or exposure to: Trauma, racism, substance abuse, poverty, family dysfunction, and homelessness. Each time this topic appears in a reading or unit, it is marked on the syllabus. The experiences of being triggered versus intellectually challenged are different. The main difference is that an individual must have experienced trauma to experience being triggered, whereas an intellectual challenge has nothing to do with trauma. If you are a trauma survivor and encounter a topic in this class that is triggering for you, you may feel overwhelmed or panicked and find it difficult to concentrate. In response, I encourage you to take the necessary steps for your emotional safety. This may include leaving class while the topic is discussed or talking to a therapist at the Counseling Center. Should you choose to sit out on discussion of a certain topic, know that you are still responsible for the material; but we can discuss if there are other methods for accessing that material, and for assessing your learning on that material. Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of community health nursing and I will support you throughout your learning in this course.

All assignments are to be submitted by the due dates. Late assignments may affect a student's scoring on the Clinical Performance Evaluation.

CLINICAL DRESS CODE: COMMUNITY SETTINGS

Students are required to adhere to professional standards while students at PLNU.

- 1. PLNU-issued green polo shirt, kept clean and unwrinkled.
- 2. Black scrub pants, kept clean and unwrinkled.
- 3. PLNU student nurse ID badge that is worn above the waist and visible at all times.
- 4. A lab coat or plain black sweatshirt/jacket may be worn if the student is cold.
- 5. Clean, low-heeled shoes with closed toes. Clogs must have a strap around the heels. No sandals or flip-flops. Shoes must be white or black.
- 6. Solid colored, neutral socks must be worn.

- 7. Jewelry: Only wedding or simple rings and limited to one per hand No piercings or jewelry/hardware may be evident other than one small stud earning per ear.
- 8. Hair color must fall within natural occurring shades, be neat, and if long, secured back. Facial hair must be neatly trimmed.
- 9. Tattoos must be covered at all times.
- 10. Fingernails must be trimmed short. Light or clear polish without chips is acceptable. No artificial or acrylic nails or components thereof are permitted.
- 11. Makeup is to be worn in moderation.
- 12. No perfumes or scented lotions.
- 13. No low necklines.
- 14. Undergarments cannot be visible through the uniform.

16 CCR § 1491

§ 1491. Qualifications and Requirements.

An applicant for a Public Health Nurse Certificate shall have a license, in active status, to practice as a registered nurse in California and shall have met the education and clinical experience requirements as follows:

- (1) Possession of a baccalaureate or entry-level master's degree in nursing from a nursing school accredited by a Board-approved accrediting body, such as the National League for Nursing Accrediting Commission, or the Commission on Collegiate Nursing Education. The baccalaureate or entry-level master's program must have included coursework in public health nursing, including a supervised clinical experience in public health settings; or
- (2) Possession of a baccalaureate or entry-level master's degree in nursing from a nursing school which is not accredited by a Board-approved accrediting body, such as the National League for Nursing Accrediting Commission or the Commission on Collegiate Nursing Education, but the Board has determined that the nursing school's public health nursing coursework and the supervised clinical experience are equivalent to that of a nursing school accredited by a Board-approved accrediting body; or
- (3) Possession of a baccalaureate degree in a field other than nursing and completion of a specialized public health nursing program that includes a supervised clinical experience at a baccalaureate school of nursing accredited by a Board-approved accrediting body, such as the National League for Nursing Accrediting Commission or the Commission on Collegiate Nursing Education.
- (4) Theoretical content for a Public Health Nurse Certificate shall include, but is not limited to, the following areas:
 - (A) Physical, mental, and developmental assessment: child and adult;
 - (B) Surveillance and epidemiology: chronic and communicable diseases;
 - (C) Health promotion and disease prevention;
 - (D) Multicultural nursing concepts;
 - (E) Research methodology and statistics;
 - (F) Health teaching concepts and strategies;
 - (G) Population based practice: assessment and development of community collaboration at the level of systems, community and family/individual;
 - (H) Assessment of health needs of individuals and families, to include environment, and interventions across the lifespan;
 - (I) Legal and health care financing issues;

- (J) Family violence, e.g., child, adult, domestic, elder abuse, etc., prevention, detection, intervention, treatment, and California reporting requirements;
- (K) Case management/care coordination; and
- (L) Emergency preparedness and response.
- (5) A faculty member of the nursing program shall be responsible for coordinating students' clinical experience and supervision.
- (6) Supervised clinical experience shall be:
 - (A) In public health settings with individuals, families, and community;
 - (B) Concurrent with or following acquisition of theoretical knowledge prescribed by the curriculum; and
 - (C) A minimum of 90 hours.
- (7) Training in the prevention, early detection, intervention, California reporting requirements, and treatment of child neglect and abuse that shall be at least seven (7) hours in length and shall be acquired through:
 - (A) A baccalaureate nursing program or a specialized public health nursing program; or
 - (B) A course of instruction in the prevention, early detection, intervention, California reporting requirements, and treatment of child neglect and abuse that is offered by a continuing education provider approved by the Board.
