Course Description

This course is designed to introduce students to the field of Psychology and the study of human behavior. It includes the topics of human development, basic understanding of the biological bases of human behavior and the mind, relationship dynamics, human sexuality, social psychology, learning, perception, cognition, normal and abnormal behavior, personality, psychological disorders, psychological testing, and an overview of therapy/therapeutic treatments.

- 5. Identify key factors that contribute to well-being.

Class topics are discussed for the sole purpose of expanding your intellectual engagement in the area of general psychological topics, and I will support you throughout your learning in this course.

Assignments At-A-Glance:

Weekly Reading Question Responses (10 points each):

Each week students will read the required chapter from Myers & DeWall and submit a 250-word response to the question provided in the Canvas Module for that week. In addition to the student's response, they will also submit at least one (1) question that they have from that week's chapter for the instructor to review before the lecture the following day. The 250-word

response and the question(s) will be submitted together on Canvas under their designated assignment tab for that week.

Midterm Reflection Paper (50 points):

Students will select a topic from one of the weeks listed in the course schedule on pages 7 & 8 of the syllabus to use for their midterm reflection paper. Students will write a 5-page paper (double-spaced, 12-point font) reflecting on the topic they have selected and how that topic applies to their lives. Students may apply the topic to their personal experiences or they may apply the topic more broadly to dynamics they have seen/witnessed elsewhere. The instructor will provide further details throughout the course, and a detailed rubric for the midterm paper will be posted in Canvas. The Midterm Reflection paper will be due Week 9 on Friday (10/27) by 11:59 pm.

Final Exam (100 points):

The final examination will consist of multiple-choice questions and short answer questions based on the readings and lecture materials covered throughout the course. The instructor will provide a study guide with the topics, terms, etc. that students will need to know for the exam. Further details and the study guide will be provided by the instructor at a later date in the course. The final exam will be due at 11:59 p.m. on Wednesday of Finals Week (12/13).
