**COURSE DESCRIPTION**

An introduction to the functions necessary for the study of calculus with an emphasis on numerical and graphical notions of continuity, limits, and derivatives. The following function types are used as examples for the study of the concepts: polynomial, rational, exponential, logarithmic, and trigonometric functions.

**COURSE LEARNING OUTCOMES**

1. Students will develop an ability to graph functions including polynomial and trigonometric functions.
2. Students will develop an ability to solve problems using polynomial, exponential, and trigonometric functions.

**COURSE CREDIT HOUR INFORMATION**

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 3-unit class delivered over fifteen weeks. ## ASSESSMENT AND GRADING

### Graded Components

- **Homework:** Homework problems will be assigned regularly and posted on Canvas. A homework assignment is late if it is not submitted at the beginning of class on the due date. Please check regularly to ensure that you are keeping up with the homework. Late homework will not be accepted. Your lowest two homework scores will be dropped.
- **Quizzes:** Quizzes will be given at the beginning of class time, so please be in your seat before the class period begins (less disruption to others). Quizzes are designed to take no more than five minutes to complete. However, ten to fifteen minutes of class time are set aside to complete these activities. Quiz dates are set in advance and are listed on the class calendar. During the course, you may find that you must be absent the day of a quiz due to a personal situation. For this reason, you are allowed to drop your two lowest quiz scores. There will be no make-up quizzes, no exceptions, so use your dropped quizzes wisely.
- **Examinations and the Final Examination.** Examinations and the Final Examination will include problems and questions over material assigned in the text, readings and handouts, as well as material presented in class. No examination shall be missed without a well-documented emergency beyond your control. A score of zero will be assigned for an examination that is missed without a well-documented emergency beyond your control.
- **Late work will not be accepted.** Homework assignments that are submitted late will be recorded with a score of zero. During the course, you may find that you are unable to submit homework on time due to a personal situation (for example, a personal or family illness, accident, business trip, etc.). For this reason, if more than half of the homework assignments are submitted on time, then the lowest two homework scores will be dropped from the calculations of the homework grade. There are not exceptions to this policy so please use your dropped assignments wisely.

### **FINAL EXAM:**

**Date and Time:** Wednesday, December 13, 2023 from 7:30am-10:00am

The final exam date and time is set by the university at the beginning of the semester and may not be changed by the instructor. This schedule can be found on the university website and in the course calendar. No requests for early examinations will be approved. Only in the case that a student is required to take three exams during the same day of finals week, is an instructor authorized to consider changing the exam date and time for that particular student.

### **Grading Scale**

Grades are based on the number of points accumulated throughout the course with the following exception. A student must pass at least one of Examination 1, Examination 2, or the Final Examination in order to pass the class. That is, a score of 60% must be achieved on one of the Examinations, or else the final grade will be an F regardless of all other point totals. Approximate minimal percentages required to obtain a given grade are:

## **FINAL EXAMINATION POLICY**

Successful completion of this class requires taking the final examination on its scheduled day. The final examination schedule is posted on the [Class Schedules](#) site. If you find yourself scheduled for three (3) or more final examinations on the same day, you are authorized to contact each professor to arrange a different time for one of those exams. However, unless you have three (3) or more exams on the same day, no requests for alternative final examinations will be granted.
