Foundational Explorations Mission

Course Description

How do Christians lead and equip others to further God's purposes? Attention is given to administration, team building, conflict resolution, and a biblical understanding of gifts, ministry roles and functions. The course also examines the pressures of ministry and the changing structures and forms of the church in American society.

Program and Course Learning Outcomes

- 1) You construct a biblical and theological understanding of pastoral leadership.
- 2) You will understand the roles and responsibilities of both clerical and volunteer staff.
- 3) The student will identify a team-based philosophy of ministry.
- 4) The student will develop a servant leadership approach in ministry.
- 5) The student will learn how to serve in a multi-ethnic leadership context.
- 6) The student will develop skills in conflict management, personal finance, and church budgets.

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. Assignments At-A-Glance

- 1. Attendance & Participation Due to this course being discussion-based, attendance is required and expected. Your attendance will contribute to both your learning and the learning of the other students in the class. Participation includes in-class exercises, participation in class activities and discussions, overall demonstrated engagement, and showing respect for your peers, the instructor(s), and the classroom environment. (100 points or 10% of total grade.)
- 2. Reading Journals Readings: Various readings from required texts and supplemental readings are assigned for this course. It is expected that you read the assigned chapters, articles, or books by the start of class period. (200 points or 20% of total grade.)

For **each reading** students will write a 200 word journal entry on Canvas with the following information on it:

- 1. Your Name
- 2. Name of Reading and Author
- 3. Main Points (2-3 min)
- 4. Critique/Limitations/Questions of the Assigned Reading
- 5. One Application of the Material to Your Life
- 3. Personal Philosophy/Theology of Leadership Utilizing course content and resources, you will be guided through composing your own Philosophy/Theology of Leadership. Also, since we are living in an age where technology and social media influences our views on leadership significantly, you will be encouraged to share Personal Philosophy/Theology of Leadership in one form of social media (Twitter, Facebook, Instagram, etc.). The process and feedback (which you may need to be intentional about soliciting) you receive on your Personal Philosophy/Theology of Leadership should be tied into your "reflection assignment." (50 points or 5% of total grade)
- 4. Reflection Assignment– One short (3-4 page) reflective paper will be based on feedback you receive on your personal Philosophy/Theology of Leadership. Further directions will be discussed in class. This reflection is graded on content (including the light and shadow aspects of self) as well as organization and grammar. (100 points or 10% of total grade)
- 5. Self-Inquiry & Discovery Action Research Project Students will have the opportunity to identify one piece of literature (must be approved) that resonates with their personal Philosophy/Theology of Leadership on a spiritual and/or holistic manner. Students will be responsible for exploring this content in connection with an action research project. Action research projects will embody the students' specified area of focus while engaging community members in participation. Students will lead at least 5 community (PLNU or local church) members in a practiced form of their leadership style while under the guidance of a PLNU Faculty or Staff member or Local Church Pastor (not the instructors). Students will submit an Action research proposal (worksheet provided) and that will be a portion of their grade. The instructor will approve all literature and project locations. Projects will be shared virtually, on YouTube or Vimeo, using creative methods of engagement. A rubric will be provided to assist students in the delivery of this project. (200 points or 20% of total grade)
- 6. Final Paper Your final paper prompt will be given in class and your final paper must be uploaded by the Final Exam time. For the full assignment reference the rubric, but it will ask that you think about your action research project. What book did you read and what did you learn from that book? How did you apply those lessons to your action research? What was your Philosophy/Theology of Leadership and how did you connect that to your action research project? Reflect (remember that is different than reporting) on the process. What went well? What would you do differently? What did you learn about yourself? Your leadership? How did the readings and lessons in class inform your learning in this process? Anything else significant we should know? (200 points or 20% of total grade)

- 7. Final Exam This exam will be an in-class short answer examination covering concepts from the class, application, and critique. We will discuss this further and you will be provided with a study guide. (150 points or 15% of total grade)
- 8. Extra Credit Extra credit opportunities will be made available to students. A one-page reflection (not a summary or report) on what you learned while attending extra credit opportunities and how it relates to your Philosophy/Theology of Leadership can earn you up to 50 points (5%) of class credit. Maximum 100 points (10%) possible.
