PLNU provides a foundational course of study in the liberal arts informed by the life, death, and resurrection of Jesus Christ. In keeping with the Wesleyan tradition, the curriculum equips students with a broad range of knowledge and skills within and across disciplines to enrich major study, lifelong learning, and vocational service as Christ-like participants in the world's diverse societies and culture.

COURSE DESCRIPTION

A survey of Western and Non-Western art history and styles through the study and criticism of painting, sculpture, and architecture from ancient civilizations to the Renaissance period.

This course directs its attention to the understanding of the Western artistic tradition over a period of centuries from ancient civilizations though the Gothic period up to the Renaissance. Philosophical and aesthetic concepts will be explored within a Christian world view, through the historical progression of art.

- 1. Demonstrate a facility for critical thinking both verbally and in writing assignments
- 2. Use common art vocabulary to discuss the visual elements.
- 3. Distinguish, describe, analyze, interpret and evaluate artworks from prehistory to the Early Renaissance.
- 4. Articulate formal, technical, historical and conceptual attributes of artworks from prehistory to the Early Renaissance
- 5. Identify and apply visual arts materials, tools, techniques and processes to historical artworks.

- 1. Learning, Informed by our Faith in Christ Students will acquire knowledge of human cultures and the physical and natural world while developing skills and habits of the mind that foster lifelong learning.
- 2. Growing, In a Christ-Centered Faith Community Students will develop a deeper and more informed understanding of others as they negotiate complex professional, environmental and social contexts.
- 3. Serving, In a Context of Christian Faith Students will serve locally and/or globally in vocational and social settings.

In some courses, a portion of the credit hour content will be delivered **asynchronously** and attendance will be determined by submitting the assignments by the posted due dates. COURSE MODALITY DEFINITIONS

- 1. In-Person: Course meetings are face-to-face with no more than 25% online delivery.
- 2. Online: Coursework is completed 100% online and asynchronously.
- 3. **Online Synchronous:** Coursework is completed 100% online with required weekly online class meetings.
- 4. Hybrid: Courses that meet face-to-face with required online components.

ASYNCHRONOUS ATTENDANCE/PARTICIPATION DEFINITION

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date. Failure to meet these standards will result in an absence for that day. Instructors will determine how many asynchronous attendance days are required each week.
