## COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1-unit, 2-unit or 3-unit class delivered over 15 weeks depending on how many units were selected. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 37.5 total hours meeting the course learning outcomes for 1 unit, an estimated 75 total hours meeting the course learning outcomes for 2 units, or an estimated 112.5 total hours meeting the course learning outcomes for 3 units. ## **ASSIGNMENTS AT-A-GLANCE**

*Short Documentary (200 points):* Students will contribute to the production of a short documentary film. The group production will be assessed for a total of 20% of the final grade.

*Short Film (200 points):* Students will contribute to the production of a short film. The group production will be assessed for a total of 20% of the final grade.

*Project Lead (200 points):* Each student will perform the role of project lead at least once. This may include specific roles on newscasts, short documentary films or a short narrative films. Performance in this role will be assessed for a total of 20% of the final grade.

*Newscasts (200 points):* Students will serve on the production crew for four newscasts. Productions will be assessed for a total of 20% of the final grade.

*Heynouncement (100 points):* Students will contribute to the production of one Heynouncement video. Heynouncements will be assessed for a total of 10% of the final grade.

*News Story (100 points):* Students will participate in the production of at least one news story for one of four newscasts during the semester. This story will be assessed for a total of 10% of the final grade.
