COURSE DESCRIPTION

This course provides students with an intensive eight-week experience in anatomical cadaver dissection and the application of structure to kinesiological function. The primary purpose of this course is to provide clinicians with a solid anatomical basis for understanding normal and abnormal function of the musculoskeletal system. This information is essential for the development of effective treatment interventions.

COURSE LEARNING OUTCOMES ⊗

The following student learning outcomes will be met in this course:

- 1. Describe the structural and functional organization of the human body and the interrelatedness of bony structures, musculature, innervation and vasculature, within each body region
- 2. Apply knowledge of the anatomic organization and relationships of structures to identify and interpret anatomic landmarks, and normal structures on cadaveric specimens
- 3. Explain the anatomic basis for common clinical conditions, injuries, pathologies, and diagnostic/interventional procedures
- 4. Demonstrate the communication and organizational skills necessary to accurately convey anatomic information with peers
- 5. Demonstrate respect, integrity, responsibility, and self-discipline toward donors, peers, and faculty
- 6. Analyze their understanding of the human body and use this information to guide their study of gross anatomy

ASSESSMENT AND GRADING

Your grades will be posted in the Canvas Grades area no later than midnight on Tuesday of each week beginning in Week Two of this course. It is important to read the comments posted in the Grades as these comments are intended to help you improve your work. Final grades will be posted within one week of the end of the class. Grades will be based on the following:

Exams: Each of the three units will have an online written exam and a lab practical exam. The written exams will be completed on Canvas and will include image identification, True or False, multiple choice, and matching questions. The written exams will be 60% of your overall grade. The lab practical exam will be completed in a scheduled lab session and assess your skills of identification. Each exam will cover the content covered in that specific unit. The Lab Practical Exams will be 30% of your overall grade.

Assignments: Additional assignments to provide practice and interaction with the content will include Study Activities aligned with the weekly lectures, and a variety of submissions as required. **Assignments will be 10% of your overall grade.**

GRADING SCALE

Final grades are calculated based on the final total points earned. There is no curve and no extra credit assignments. You will receive the grade that you earn. The point total will be converted to a percentage to assign a letter grade; therefore there will be no rounding of percentages.

ATTENDANCE

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

Synchronous Class Attendance

For synchronous courses that have specific scheduled meeting times (including in-person, hybrid, and synchronous online courses), absences are counted from the first official meeting of the class regardless of the date of the student's enrollment. For courses with specific attendance requirements, those requirements are outlined in the course syllabus. Students may be warned if a student demonstrates a lack of attendance. After a warning, if absences continue and reach a total of more than twenty percent of the course the student may be de-enrolled from the course without further advance notice to the student.

If the date of de-enrollment is past the last date to withdraw from a course, the student will be assigned a letter grade of "F" or "NC." There are no refunds for courses where a de-enrollment was processed past the last date to withdraw.

A student who registers late must, therefore, be exceptionally careful about regular attendance during the remainder of the course. Registered students who neither attend the first class session nor inform the instructor of their desire to remain in the class may, at the request of the instructor, be removed from the class roster.

Exceptions to the foregoing attendance regulations due to extenuating circumstances beyond the student's control may be granted only by appeal to the Vice Provost for Academic Studies.

Students who anticipate being absent for an entire week of a course should contact the instructor in advance for approval and make arrangements to complete the required coursework and/or alternative assignments assigned at the discretion of the instructor. Acceptance of late work is at the discretion of the instructor and does not waive attendance requirements.

Students may be warned if they demonstrate a lack of academic activity. After a warning, students who miss more than one week of academic activity without prior approval and arrangements with the instructor may be de-enrolled or withdrawn from a course.
