Students will build a portfolio website and produce advanced multimedia elements for it, blending text, audio, video, photos, data visualizations, and interactivity.

## Assignments

*Photojournalism (100 points)*: Tell a news story with a photograph and its caption.

Audio Postcard (100 points): Tell a news story with a photograph and audio.

*Photo Series (100 points)*: Tell a news story with a series of photographs.

Video Story (100 points): Tell a news story with a series of edited video clips.

Multimedia Story (100 points): Tell a news story using online multimedia tools.

Final Website Presentation (100 points): Present a portfolio of your work to the class.

#### State Authorizations
