Assignments

Photojournalism (100 points): Tell a news story with a photograph and its caption.

Audio Postcard (100 points): Tell a news story with a photograph and audio.

Photo Series (100 points): Tell a news story with a series of photographs.

Video Story (100 points): Tell a news story with a series of edited video clips.

Multimedia Story (100 points): Tell a news story using online multimedia tools.

Final Website Presentation (100 points): Present a portfolio of your work to the class.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive the appropriate grade for their work and participation.
