COURSE DESCRIPTION

Within the context of Christian origins, an overview of the canonical literature of the New Testament with special attention to its literary history and theological themes.

PROGRAM GOAL

PLNU's Christian studies programs equip you with a foundational knowledge of Scripture and theology, as well as the practical experience essential for ministry and service, enabling you to courageously confront the problems facing our world today.

Students will acquire knowledge of human cultures and the physical and natural world while developing skills and habits of the mind that foster lifelong learning.

3. Serving, In a Context of Christian Faith

Students will serve locally and/or globally in vocational and social settings.

- 1. Identify the historical contexts of the New Testament.
- 2. Articulate the unity of the New Testament in its canonical context within the diverse literature of the Christian canon.
- 3. Articulate and appreciate the ways in which the Bible, understood as given by divine inspiration, functions as the church's central norm for Christian discipleship, faith and practice.
- 4. Articulate the basic content of the books of the New Testament and the methods appropriate to the interpretation of those books.

ASSESSMENT AND GRADING

The following components will be present in the course to assess your learning:

- 1. **Readings** The New Testament is the primary text for this course. All readings are required. It is important to keep up with the readings on a session-by-session basis or the information will quickly become overwhelming. There will be both weekly quizzes ("Celebrations of Learning") and discussion forums aligned to the reading each week.
- 2. **Discussions** will be based on your observations from the assigned reading. **Discussions will make up 30% of your overall grade**.
 - Your initial post will contain three significant statements or points made or things you observed in the
 readings themselves (whether the biblical passages or textbooks) with an explanation for each of them
 and why you thought they were significant. Note: the initial post should be a total of 400 words for
 all three observations.
 - Responses are required to at least two classmates to thoughtfully engage with their post and offer some responses that examine their observations or ask questions of them or even add to what they observed. Note: responses should be 200 words total for the two responses combined.

- 3. Celebrations of Learning (a.k.a. reading quizzes) **Quizzes will make up 50% of your overall grade.**These will cover various reading assignments and associated class lectures. There are "Celebrations" each week (often called, erroneously, "quizzes" :-) and study guides ("Party Favors"!) will be provided.
- 4. **Assignments** will include Pre-lecture reflections, the end-of-course evaluation, a chance for extra credit and the Final Celebration of Learning will be a short reflective essay (a.k.a. final exam) at the end of the course. **Final Celebration will make up 20% of your overall grade.**

Assignments will be graded as soon after the due date as possible and feedback will be given on your assignments. It is important to read the comments posted in the Grades area and on your document submissions as these comments are intended to help you improve your work. You can expect an email response from me within 24-48 hours. Your grades will be posted in the Canvas Grades area no later than Friday of each week beginning in Week Two of this course. LATE ASSIGNMENTS

All assignments are to be submitted by the due dates. There will be a 10% reduction of possible points for **each day** an assignment is late and assignments will **not be** accepted for credit four days after the due date. If missing assignments result in the failure to meet learning outcomes, students may receive a letter grade reduction on the final grade in addition to the loss of points for missing work. Assignments will be considered late if posted after the due date and time using Pacific Standard Time. No assignments will be accepted after midnight on Sunday night, the last day of class.

Exceptions for extenuating circumstances must be pre-approved by the instructor and the program director.

STATE AUTHORIZATION

State authorization is a formal determination by a state that Point Loma Nazarene University is approved to conduct activities regulated by that state. In certain states outside California, Point Loma Nazarene University is not authorized to enroll online (distance education) students. If a student moves to another state after admission to the program and/or enrollment in an online course, continuation within the program and/or course will depend on whether Point Loma Nazarene University is authorized to offer distance education courses in that state. It is the student's responsibility to notify the institution of any change in his or her physical location. PLNU ATTENDANCE AND PARTICIPATION POLICY

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university drop date or, after that date, receive an "F" grade.

COURSE MODALITY DEFINITIONS

- 1. **In-Person:** Course meetings are face-to-face with no more than 25% online delivery.
- 2. **Online:** Coursework is completed 100% online and asynchronously.
- 3. **Online Synchronous:** Coursework is completed 100% online with required weekly online class meetings.
- 4. **Hybrid:** Courses that meet face-to-face with required online components.

In some courses, a portion of the credit hour content will be delivered asynchronously and attendance will be determined by submitting the assignments by the posted due dates. See <u>Academic Policies</u> in the Undergraduate Academic Catalog.

ASYNCHRONOUS ATTENDANCE/PARTICIPATION DEFINITION

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date. Failure to meet these standards will result in an absence for that day. Instructors will determine how many asynchronous attendance days are required each week.
