COURSE DESCRIPTION

This 8-week course will have an overarching vision of introducing students to the quickly growing world of Culinary Medicine. We will explore the spaces into which culinary medicine is currently being utilized in the three larger spaces of: healthcare, food service and the community. We will experience the full space of Culinary Medicine by spending time diving into evidence-based nutrition research and then using that information in hands-on sessions utilizing Culinary Medicine principles. We will dive deep into the areas that affect people's access to food. Throughout the quarter we will be creating a tangible portfolio that will include a case study of a specific patient or client that would benefit from Culinary Medicine knowledge in action. This portfolio will include the case study, three recipes that piggyback off the medical condition(s) being addressed, an infographic to cement the principles of your teaching points. These aspects I think of as the 'front of the house'. We will also create a 'back of the house' portfolio which will include spending time in the space of intrapreneurship and entrepreneurship creating proposals, flexible biographies and marketing kits.

Note: Logging into the course does not qualify as participation and will not be counted as meeting the attendance requirement.
