

Point Loma Nazarene University exists to provide higher education in a vital Christian community where minds are engaged and challenged, character is modeled and formed, and service becomes an expression of faith. You will watch a pre-recorded short lecture and do the reading and quiz BEFORE class. All content will be posted in each module, including a PowerPoint to follow while you watch the lecture. The first section of class meetings will happen with our whole group and then I will break you out in smaller groups for our compendium activities. Once you complete your compendium activity, you will post it on our classroom community space for others to see.

#### **COURSE DESCRIPTION**

Examination of commonly prescribed psychopharmacological medications, as well as the identification of their effects and side effects.

**Additional Information:** Psychopharmacology (2 semester units or 3 quarter units only for those who entered a qualifying degree program on or after 1/1/2001) and a two semester or three quarter unit course in psychopharmacology (LPCC).

This course meets the criteria for MFT and includes instruction in diagnosis, assessment, prognosis, and treatment of mental disorders, including severe mental disorders, evidence-based practices, psychological testing, psychopharmacology, and promising mental health practice that are evaluated in peer reviewed literature (BPC Section 4980.36(d)(2)(A)).

The use of psychotropic medications as a treatment for mental and emotional disorders has been increasing substantially in recent years. Counselors in community and school settings are very likely to be working with clients who have been prescribed medication, or who may need to consider medication as an adjunct to therapy. It is important for counselors to understand the basic concepts of pharmacology, mechanisms of drug actions, and the use of psychotropic drugs in treating psychological disorders. This course will provide an introduction to psychopharmacology and the clinical issues that counselors encountry working with clients on medication.

#### How to Succeed in this Course:

This course is a significant departure from your training in clinical evaluation and counseling skills. You will be revisiting topics reminiscent of your high school and undergraduate biology and chemistry days, a task that poses a challenge to many students who do not believe themselves to be "good" in these subjects. My objective is for you to gain a deeper understanding of the neurobiological correlates of mental disorders and adopt the language of psychiatry that will give you unique interdisciplinary skills. To be successful, several things are essential. First, you must do your reading prior to class to ensure that you have a foundation for the clinical examples discussed. We will go deeper into the topics within our class time and it is a great chance to *build* on your learning from reading rather than starting from scratch. Second, turn things in on time and don't fall behind, we move at a fast pace. Don't wait until the last minute. Finally – I grade mostly on three things: effort, critical thinking, and timely completion. For the journal clubs, I want to see that you are wrestling with the topic and spending the necessary time and energy that it takes to thoughtfully and critically evaluate these complex issues.

## **GROUND RULES OF THE COURSE**

Together we will create a dynamic learning environment where:

- 1. Learning is challenging but safe
- 2. Learning is experiential and active
- 3. Communication is open . . . opposing viewpoints are welcomed
- 4. All are learners and all are teachers . . . we will learn from each other
- 5. Mistakes are okay . . . this is a no-guilt, no-blame zone
- 6. The point is to learn and grow ... grades are a by-product and not the goal
- 7. Integrity and honesty are expected

#### **COURSE LEARNING OUTCOMES**

After completing this course, you should be able to:



- 1. Demonstrate a basic understanding of the structure and function of the central nervous system in relation to drug action.
- 2. Become familiar with physiological, cognitive, behavioral, and therapeutic effects of both common psychotropic medication and relevant illicit substances.
- 3. Apply peer-reviewed empirical research to evaluate prevailing methodologies of a) psychopharmacological intervention and b) substance abuse treatment.
- 4. Develop awareness of cultural influences that contribute to society's broader disposition toward medication and drug use.

This is a didactic course with three goals: 1) to acquire a body of knowledge of psychotropic medications, their properties, clinical applications, and effects; 2) to analyze and integrate this body of knowledge into your own clinical practice; and 3) to enhance the well-being of your clients through collaboration and cooperation between psychotherapists and physicians.

#### COURSE REQUIREMENTS

Students are expected to participate in online assignments that are due by **11:59 p.m. on the day indicated on the syllabus** to be considered for full credit. **There will be NO make-up assignments.** It is your responsibility to check the e-classroom regularly to ensure you complete assignments on time. There are no make-ups or extended time for assignments or presentations.

At a minimum, every student is responsible for completing the following weekly tasks:

- 1. Participate and complete all class activities.
- 2. Timely submission of assignments, as instructed.

**Deadlines:** Do **not** wait until the last minute to do your work! As this is a graduate level course, you will be expected to meet deadlines.

**Electronic Devices: A strict no laptop or smartphone policy applies to this class.** All electronic devices must be turned off upon entering class. This includes laptops, cell phones, tablets, and others not mentioned.

- 1. **Pre-Class Preparation:** Students will reflect on each week's learning prior to our class. Please answer the questions (and ask some of your own) in response to your reading. Note that some of the questions come from the Preston text. Lectures/Powerpoints are also pre-posted if you'd like to watch them at any point (optional).
- 2. Quizzes: Students will complete a total of 10 quizzes that will review the reading materials for the class. All questions are based on the class textbook (Prus). The quizzes questions will be taken on Canvas. A quiz will cover the textbook chapter and are due BEFORE class. See assignment guide for due dates. All quizzes will be available online at all times and can be completed before their due dates. Quizzes will not be scored *after* their due dates. Please note that I have encountered instances of students using websites that archive test bank questions. You may find yourself tempted to simply google the questions and find the answers. Please be aware that this is a very serious matter and I will treat the offense as a matter of academic dishonesty. If I suspect you are using these resources, I will *at my discretion* give you a 0 for the quiz in question and initiate the protocol for academic dishonesty which may result in you failing the course. I expect you to hold yourself to a high standard of integrity and cheating in this manner is not consistent with our classroom culture or values.

- 3. Chapter Readings/Podcast Reflection papers (4 x 50) Chapters from three books are uploaded to Canvas. There is one podcast to list to. Reflection papers for each assignment communicating what aspects or clinical insight did you derive from this reading. How has it changed your clinical assessment and, or treatment of your patients? APA 7, no running head or abstract.
- 4. Attendance and Participation: You will receive 5 points for attendance and 5 for participation each day of class (10 x 14 = 140). Coming to class and participating in discussion and class activity is mandatory and expected. However, I am entirely sympathetic to extenuating circumstances that may result in a student missing class. Tardiness of greater than 15 minutes to a class will be counted as an absence. Note: you are only allowed TWO total absences, per MACC/PLNU attendance policy, and any additional absences may result in de-enrollment from the class. Bottom line: If you come to class and participate, you will receive full points and this component of the final grade will only help you! ## ATTENDANCE AND PARTICIPATION

Regular and punctual attendance at all class sessions and discussions is considered essential to optimum academic achievement.
