COURSE DESCRIPTION

This course examines cultural influences and differences, in addition to issues of diversity, equity, and inclusion. Students will learn how to develop increased awareness and appreciation for diverse backgrounds in order to foster collaborative relationships and environments. Emphasis is placed on developing cultural intelligence and strategies to lead diverse teams.

- 4. Devise approaches to effectively navigate cultural influences and diversity in the workplace to achieve organizational goals (PLO 5).
- 5. Interpret how personal beliefs and values regarding different people impact perceptions and personal interactions (PLO 3).
- 6. Demonstrate effective communication through verbal and written means (PLO 2).

COURSE CREDIT HOUR INFORMATION (required for online and hybrid delivery ONLY)

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 3 unit class delivered over 8 weeks. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. Written Assignments

There is a written assignment due in Week One through Week Nine of this course. These assignments must reflect college-level writing and critical thinking. **Assignments represent 70% of the overall course grade.**

Final Projects

The final assignments for this course are the Leadership Development Project and the Summary Reflection. The purpose of the Final Projects is for students to culminate the learning achieved in the course. **Final Projects represent 30% of the overall course grade.**

- 1. Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a. Synchronous Courses: At least one class meeting takes place at a designated time.
 - b. Asynchronous Courses: All class meetings are asynchronous.
- 2. Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

PLNU ATTENDANCE AND PARTICIPATION POLICY **★**

Face-to-Face BBA/BAOL Courses:

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. Therefore, regular attendance and participation in each course are minimal requirements.

If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.
