### **Course Description** ⊕

An independent investigation, under faculty supervision, of a specific problem at the frontier of a chemical field.

Includes weekly discussion sessions. May be repeated up to a maximum of four (4) units.

Course Learning Outcomes: Students will:

- Develop hands-on chemistry skills and practice beyond that achieved in traditional chemistry course and laboratory work.
- Solve research problems as they arise.
- Develop the work ethic and initiative to persevere in research with reasonable oversight from the faculty mentor.

## Assessment and Grading★

Students will be assessed based on the following criteria:

- Time investment: For each credit hour of CHE4099, students are expected to spend an average of at least 3 hours per week working on their research.
- Work ethic: Students are expected to exhibit a strong work ethic and initiative to persevere in their research project, with reasonable oversight from their faculty mentor.

Grades will be assigned by the faculty mentor as follows:

- **A grade**: Meets all of the criteria.
- **B grade**: Meets most of the criteria.
- **C grade**: Meets some of the criteria.
- **F grade**: Meets none of the criteria.

### **PLNU Attendance and Participation Policy**⊕

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. If the student is absent for more than 10 percent of class sessions, the faculty member will issue a written warning of de-enrollment. If the absences exceed 20 percent, the student may be de-enrolled without notice until the university withdrawal date or, after that date, receive an "F" grade.
