PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a) Synchronous Courses: At least one class meeting takes place at a designated time.
 - b) Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

ASSIGNMENTS AT-A-GLANCE

See Canvas for deadlines and assignment details.

Chapter Quizzes (280 points): Open-book reading quizzes will be conducted outside of class across chapters in *Introduction to Mass Communication: Media Literacy and Culture*, 2024 Edition. Baran. Quizzes will be assessed for a total of 28% of the final grade.

Participation (205 points): Attendance, in-class engagement, Canvas discussions and participation in group projects are expected. Participation will be assessed for 20.5% of the final grade.

YouTube Videos (150 points): Students will produce two videos individually and two in groups. These projects will be assessed collectively for 15% of the final grade.

Media Consumption (65 points): Students will track their own media consumption and respond with a written reflection. These assignments will be assessed collectively for 6.5% of the final grade.

Timeline Reel (50 points): Students will work in groups to produce a vertical video using the genre conventions of Instagram, YouTube or TikTok about the historical timeline for a particular medium. This project will be assessed for 5% of the final grade.

Industry Research (50 points): Students will select a job within a media-related profession and identify skills, experiences and aptitudes needed to be considered for a particular role. Students will conduct peer review of these submissions and reflect on what they've learned. This work will be assessed collectively for 5% of the final grade.

Content Creator Report (50 points): Students will identify an influencer or content creator and report on various aspects of their work. Students will conduct peer review of these submissions and reflect on what they've learned. This work will be assessed collectively for 5% of the final grade.

Media Fast (50 points): Students will identify an area of media consumption to remove from their daily diet for an allotted amount of time. Written reflections on the experience will be assessed for 5% of the final grade.
