PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
 - a) Synchronous Courses: At least one class meeting takes place at a designated time.
 - **b)** Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

ASSIGNMENTS AT-A-GLANCE

Participation (350 points): Attendance, in-class engagement and online Canvas discussions are expected. Participation will be assessed for 35% of the final grade.

Assignments (600 points): Students will shoot, edit and submit photography assignments each week. These projects will be assessed collectively for 60% of the final grade.

Final Presentation (50 points): Students will present a collection of their best work during the final exam time. This will be assessed for 5% of the final grade.
