#### **COURSE CREDIT HOUR INFORMATION**

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 1-unit, 2-unit or 3-unit class delivered over 15 weeks depending on how many units were selected. It is anticipated that students will spend a minimum of 37.5 participation hours per credit hour on their coursework. For this course, students will spend an estimated 37.5 total hours meeting the course learning outcomes for 1 unit, an estimated 75 total hours meeting the course learning outcomes for 2 units, or an estimated 112.5 total hours meeting the course learning outcomes for 3 units. #### PLNU COURSE MODALITY DEFINITIONS

- 1) Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
  - a) Synchronous Courses: At least one class meeting takes place at a designated time.
  - **b)** Asynchronous Courses: All class meetings are asynchronous.
- 2) Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3) In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

#### **ASSIGNMENTS AT-A-GLANCE**

See Canvas for deadlines and assignment details.

*Short Film (100 points):* Students will contribute to the production of a short film. The group production will be assessed for a total of 10% of the final grade.

*Short Documentary (100 points):* Students will contribute to the production of a short documentary film. The group production will be assessed for a total of 10% of the final grade.

*Project Lead (100 points):* Each student will perform the role of project lead at least once. This may include specific roles on studio shoots, short documentary films or a short narrative films. Performance in this role will be assessed for a total of 10% of the final grade.

*Hours Log (100 points):* Students will log the production hours they complete in compliance with the required minimum hours per credit unit. Completion of the log will count toward 10% of the final grade.

*Studio Shoots (300 points):* Students will serve on the production crew for six client shoots in the TV studio. Written reflection on these experiences will be assessed for a total of 30% of the final grade.

Attendance (300 points): Attendance is required and will count toward 30% of the final grade.
