# Course Description ↔

• A study of representative works of literature and cultural contexts.

This course is one of the components of the General Education Program at Point Loma Nazarene University, under the category of "Seeking Cultural Perspectives." By including this course in a common education experience for undergraduates, the faculty supports the survey of human endeavors from a historical, cultural, linguistic, and philosophical perspective, including developing a critical appreciation of human expression – both artistic and literary. In this survey of major literary texts of Science-Fiction Literature students will recognize the features of the texts and their genres, gain a sense of their historical, cultural, and literary contexts, and develop their own critical reading, thinking, writing, and speaking skills.

Regular and punctual attendance at all class sessions is considered essential to optimum academic achievement. # **PLNU Course Modality Definitions**

- **1.** Online Courses: These are courses with class meetings where all instruction and interaction is fully online.
  - **a.** Synchronous Courses: At least one class meeting takes place at a designated time.
  - **b.** Asynchronous Courses: All class meetings are asynchronous.
- **2.** Hybrid Courses: These are courses with class meetings that take place both in the classroom and online synchronously and/or asynchronously.
- 3. In-Person Courses: These are courses that meet in person with the instructor and students in a physical classroom setting. With approval by the area dean, this may include up to 25% of qualified class interactions through a Learning Management System (such as Canvas).

In some courses, a portion of the credit hour content will be delivered asynchronously and attendance will be determined by submitting the assignments by the posted due dates. See <u>Academic Policies</u> in the Undergraduate Academic Catalog.

# Asynchronous Attendance/Participation Definition

A day of attendance in asynchronous content is determined as contributing a substantive note, assignment, discussion, or submission by the posted due date.
