#### **Course Description**

An advanced study of selected authors and movements in American literature since 1900. The course will offer students the opportunity to study a limited number of texts in greater depth than is possible in a survey course. This semester we will be reading works published in the 21<sup>st</sup> century.

- 5. Present creative and/or analytical writing to formal audiences, demonstrating strategies for audience engagement and oral communication. (Oral Communication)

#### **Course Learning Outcomes**

At the Conclusion of the Course Students will be able to:

- Closely read and critically analyze texts in their original languages and/or in translation.
- Recall, identify, and use fundamental concepts of literary study to read and discuss texts
  - Standard literary terminology
  - Modes/genres of literature
  - Elements of literary genres
  - Literary periods (dates, writers, characteristics, and important developments)
  - Contemporary critical approaches
  - Extra-literary research
- Analyze the social, cultural, ethnic, gendered, and/or historical contexts of the works and their authors, and connect the texts with their own lives.
- Create detailed and informed textual analysis of literary works that examine several of the fundamental concepts of literary study.

#### **Required Texts**

Junot Diaz, The Brief Wonderous Life of Oscar Wao Cormac McCarthy, No Country for Old Men Viet Thanh Nguyen, The Sympathizer Taylor Jenkins Reid, Daisy Jones & The Six Marilynne Robinson, Gilead George Saunders, Tenth of December: Stories

#### **Course Requirements**

*Reading:* Dates for the readings are clearly indicated on the schedule. Read daily if possible and complete all reading on time.

*Discussion:* The success of the course will be directly related to the quality of our daily discussions. Each of you must feel comfortable contributing to discussions. And each of you should bring any questions you have about the reading to our attention during the course of our discussions.

*Writing*: Each undergraduate student will complete a mid-term exam, a final exam, and a brief research-based paper of 3-4 pages. Each graduate student will complete a mid-term exam, a final exam, and a research-based paper of 7-10 pages.

*Discussion Leadership:* Graduate students will be called upon to help lead the discussion of one of the writers.
