Study of an area of computer security otherwise included in the curriculum. Topics are determined by the needs and interest of the students and faculty involved. May be repeated up to a total of four (4) units.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 2 unit class delivered over sixteen weeks. CLASS ENROLLMENT:

ASSESSMENT AND GRADING

Graded Components

- **Homework**: Homework will be assigned each week and will be due before class on Monday.
- Tool Demonstration Project: You will have a group project where you need to give a short presentation in class. Details will be given later in the semester.
- **Final Project:** You will be assigned a topic to present instead of a final exam. These will be small group projects and there will be several submission points along the way to check that you are on track in preparing the presentation. These project reports will be presented on the night of the final exam Monday December 16 7:30-10:00 PM. Each member of your team will be given a survey to assess the contributions of the other team members to the project. Lack of participation in the work of your team will have an impact on your individual grade for the project.
- Late work will not be accepted without prior consent or a well-documented emergency. All course assignments that are submitted late without prior consent will be recorded with a score of zero. If more than half of the homework assignments are submitted on time, then the lowest homework score will be dropped from the calculations of the homework grade.
