COURSE DESCRIPTION

A calculus course intended for those studying business, economics, or other related business majors. This course covers differential and integral calculus of elementary functions with an emphasis on business applications. This is a brief calculus course and not appropriate for students majoring in science, computer science or mathematics.

COURSE CREDIT HOUR INFORMATION

In the interest of providing sufficient time to accomplish the stated Course Learning Outcomes, this class meets the PLNU credit hour policy for a 3-unit class delivered over fifteen weeks. ASSESSMENT AND GRADING

Graded Components

- **Online Homework:** This homework is completed in MyLab Math, available through the online access key. You will have multiple attempts to complete each problem. Each section covered in class will have associated problems assigned online. Late homework will not be accepted. Your lowest two online homework scores will be dropped.
- **Written Homework:** Homework problems will be assigned regularly and posted on Canvas. A homework assignment is late if it is not submitted at the beginning of class on the due date. Please check regularly to ensure that you are keeping up with the homework. Late homework will not be accepted. Your lowest two written homework scores will be dropped.
- **Examinations and the Final Examination.** Examinations and the Final Examination will include problems and questions over material assigned in the text, readings and handouts, as well as material presented in class. No examination shall be missed without a well-documented emergency beyond your control. A score of zero will be assigned for an examination that is missed without a well-documented emergency beyond your control.
- **Late work will not be accepted.** Homework assignments that are submitted late will be recorded with a score of zero. During the course, you may find that you are unable to submit homework on time due to a personal situation (for example, a personal or family illness, accident, business trip, etc.). This is why your lowest assignments will be dropped, as described above. There are no

exceptions to this policy so please use your dropped assignments wisely.

FINAL EXAM:

Date and Time: Thursday, December 19th from 1:30-4:00pm.

The final exam date and time is set by the university at the beginning of the semester and may not be changed by the instructor. This schedule can be found on the university website and in the course calendar. No requests for early examinations will be approved. Only in the case that a student is required to take three exams during the same day of finals week, is an instructor authorized to consider changing the exam date and time for that particular student.

Grading Scale

Grades are based on the number of points accumulated throughout the course with the following exception. A student must pass at least one of Examination 1, Examination 2, or the Final Examination in order to pass the class. That is, a score of 60% must be achieved on one of the Examinations, or else the final grade will be an F regardless of all other point totals. FINAL EXAMINATION POLICY

Successful completion of this class requires taking the final examination on its scheduled day. The final examination schedule is posted on the [Class Schedules](#) site.
